The undersigned, being first-duly sworn, makes this sworn statement of intention to hold lien upon the property described below and says that:

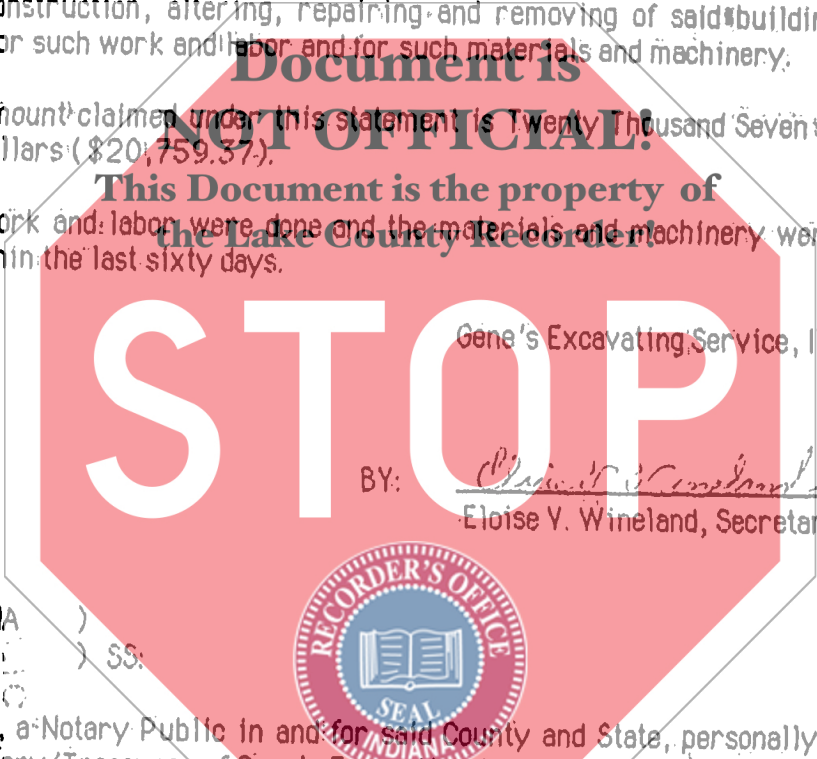
