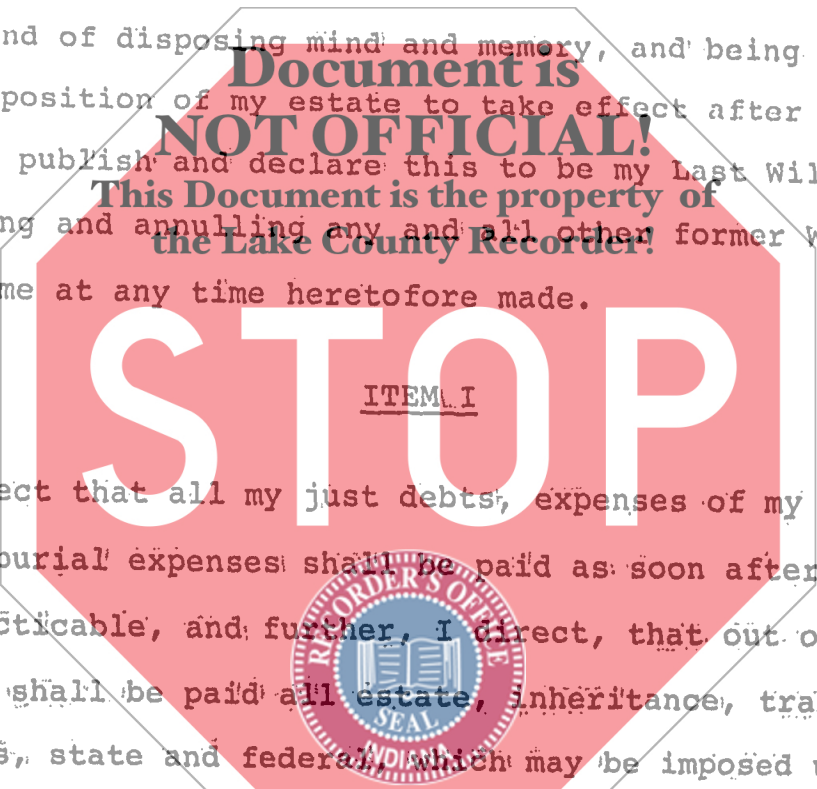

ITEM I

I direct that all my just debts, expenses of my last illness, funeral and burial expenses shall be paid as soon after my demise as shall be practicable, and further, I direct, that out of the residue of my estate shall be paid all estate, inheritance, transfer and succession taxes, state and federal, which may be imposed upon my property or estate or on any bequest, devise or other interest under this Will, or on any other property, taxable by reason of my death.

ITEM II

I give, bequeath and devise all of my property, real, personal, or mixed, wheresoever situate, to which I may be entitled, or over

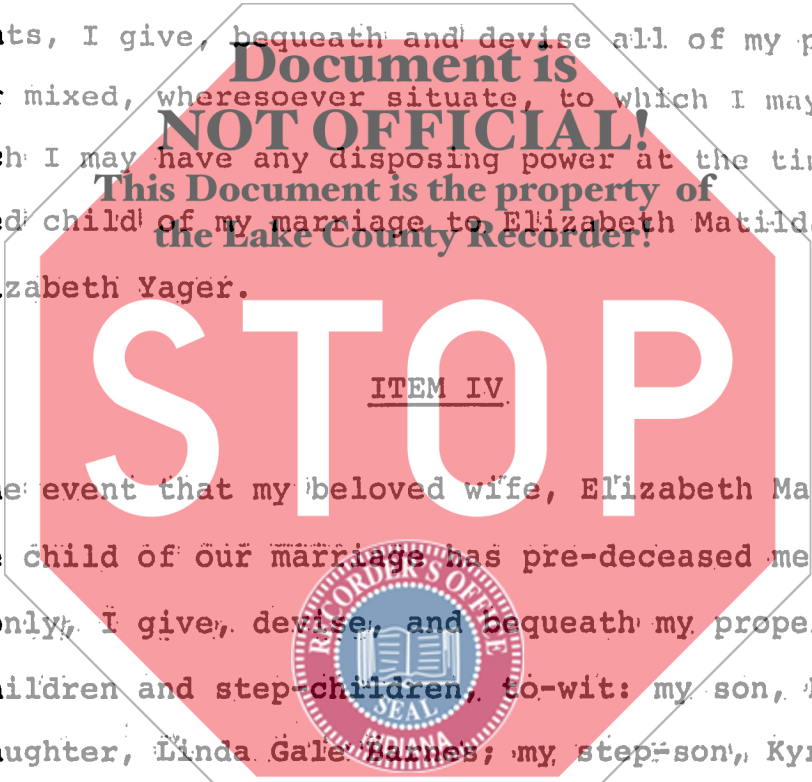

ITEM III

If my said wife shall predecease me, or if we shall die in a common disaster, accident, calamity, or catastrophe, then, and in any of said events, I give, bequeath and devise all of my property, real, personal, or mixed, wheresoever situate, to which I may be entitled, or over which I may have any disposing power at the time of my death, to my beloved child of my marriage to Elizabeth Matilda Yager, namely, Michelle Elizabeth Yager.



ITEM IV

In the event that my beloved wife, Elizabeth Matilda Yager, and the true child of our marriage has pre-deceased me, then, in such event only, I give, devise, and bequeath my property to my following children and step-children, to-wit: my son, Ronald Eugene Yager; my daughter, Linda Gale Barnes; my step-son, Kyrle Williamson; my step-daughter, Ingrid E.L. Williamson; my step-daughter, Nancy Ann Williamson; my step-daughter, Rita Lyn Williamson; my step-daughter, Cindy Faye Williamson; my step-daughter, June Ann Williamson; and my step-daughter, Christa Marie Williamson, in equal shares.

ITEM V

If any legatees or devisees shall die simultaneously with me or under such circumstances as to render it difficult or impossible to determine who predeceased the other, I hereby declare that I shall

be deemed to have survived such legatees or devisees and that this Will and all of its provisions shall be construed upon that assumption and basis.

ITEM VI

I nominate, constitute and appoint my wife, Elizabeth Matilda Yager, Executrix of this Last Will and Testament; but if my said wife shall predecease me, or if we shall die in a common disaster, accident, calamity, or catastrophe, or if my wife chooses not to serve as Executrix, then, and in any of said events, I nominate, constitute and appoint Michelle Elizabeth Yager, as Executrix of this Last Will and Testament; and I direct that no bond or other undertaking shall be demanded of my Executrix.

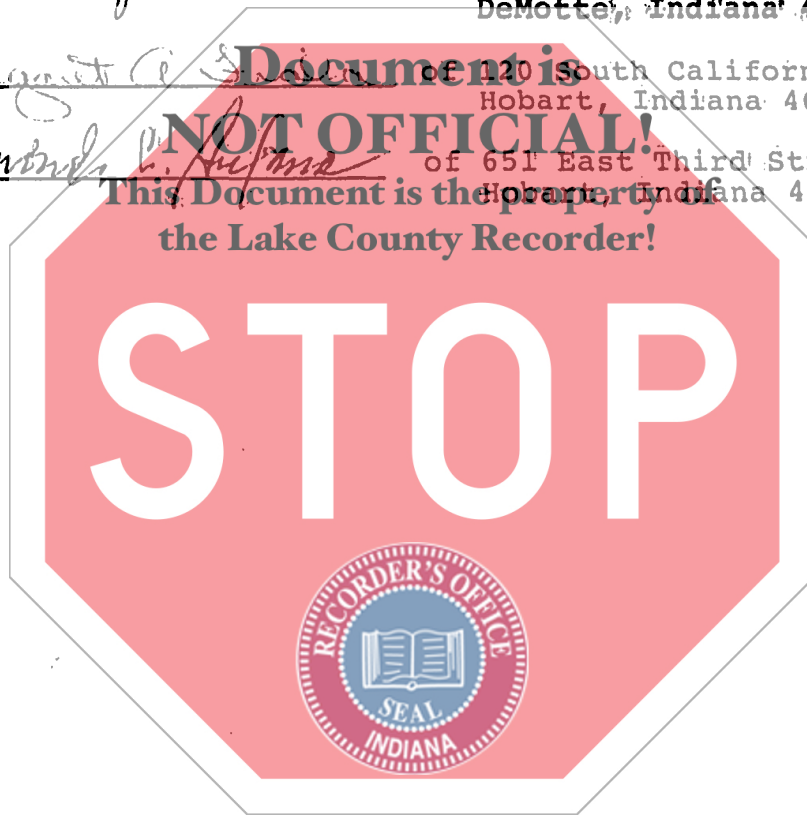
