LOANEMODIFICATION AGREEMENT

WHEREAS, Citizens Federal Savings and Loan Association of Hammond, Indiana (Lender) granted a Line of Credit to E. David Hein: and Margaret A. WHEREAS, Borrower has requested a modification of the ferms of said loan for the purpose of increasing the Credit Limit from \$20,000.00 to \$32,000.00;

WHEREAS, in consideration of Lender's consent to the above Credit Limit increase, Borrower shall pay to Lender an appraisal fee, title expense, recording fees and a processing fee;

THEREFORE, it is hereby agreed that the original terms of said Contract and Mortgage are modified as follows:

- 1. The Credit Limit is increased to \$32,000.00;
- 2. Borrower may not draw on the line of Credit in excess of \$20,000.00 until after the three day cancellation period has expired (which is explained in a separate Notice of Right to Cancel Borrower was given).
- 3. Borrower has paid Lender an appraisal fee, title expense, recording fee and a Processing Fee, the receipt of which is hereby acknowledged; and
- 4. Nothing in this Agreement shall be understood or construed to be a satisfaction or release in whole or in part of the Loan Documents. Except as otherwise specifically provided in this Agreement, the Loan Documents will remain unchanged and in full effect, and the Borrower and Lender will be bound by, and comply with, all of the terms and provisions thereof, as amended by this Agreement.
