in the State of Indiana, to-wit:

Part of the Southeast $\frac{1}{4}$ of the Southeast $\frac{1}{4}$ of Section 4, Township 36 North, Range 7 West of the 2nd Principal Meridian, in the City of Gary, Lake County, Indiana, described as follows: Beginning at a point on the Northernly right of way line of U.S. Highway 20, (which highway at this point is 200 feet wide) which point is 720.147 feet West of the East line of said Section, measured along the Northernly right of way line of said Highway; thence North and parallel with the East line of said $\frac{1}{4}$ Section, a distance of 350.98 feet to the Southerly right of way line of the Baltimore and Ohio Railroad; thence Northwesterly along the Southerly right of way line of the said Railroad with an interior angle of $102^{\circ} 43' 30''$ to a point, said point being 153.05 feet West of and at right angles to the last described North and South line of extended North; thence South on a line with an interior angle of $77^{\circ} 16' 30''$ and parallel to the East line of said $\frac{1}{4}$ section a distance of 390 feet, more or less, to the Northernly right of way line of U.S. Highway No. 20, (which highway at this point is 150 feet wide) thence Easterly along the Northernly right of way line of U.S. Highway No. 20, a distance of 150 feet, more or less, to a point where the North $\frac{1}{2}$ of said Highway ends its 75 feet width and begins its 100 feet width; thence Northernly 25 feet, more or less, to the place of beginning, commonly known as 9340 Melton Road, Gary, Indiana.

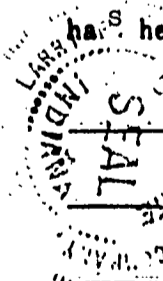
