6. Occupancy, Preservation, Maintenance and Protection of the Property; Borrower's Loan Application; Beascholds. Borrower shall occupy, establish, and use the Property as Borrower's principal residence within sixty days after the execution of this Security instrument and shall continue to occupy the Property as Borrower's principal residence for at least one year after the date of occupancy unless Lender otherwise agrees in writing which consent shall not be unreasonably withheld, or unless extenuating circumstances exist which are beyond Borrower's control. Borrower shall not destroy, damage or impair the Property ullow the Property to determine or commit waste on the Property. Borrower shall be in default if any forfeiture action or proceeding, whether civil or criminal, is begun that in Lender's good faith judgment could result in forfeiture of the Property or otherwise materially impair the lien created by this Security Instrument or Lender's security interest. Borrower may cure such a default and reinstate, as provided in paragraph 18, by causing the action or proceeding to be dismissed with a ruling that, in Lender's good faith determination, precludes for feiture of the Borrower's interest in the Property or other material impairment of the lien created by this Security Instrument or Lender's security interest. Loan Charges, If the loan secured by this Security Instrument is subject to a law which sets maximum#loan charges, and that law is finally interpreted so that the interest or other loan charges collected or to be collected in connection with the loan exceed the permitted limits, then: (a) any such loan charge shall be reduced by the amount necessary to reduce the charge to the permitted limit; and (b) any sums already enliced from Borrower, which exceeded permitted limits will be refunded to Borrower. - 14. Notices. Any notice to Borrower provided for in this Security Instrument shall be given by delivering it or by mailing it by first class mail unless applicable law requires use of mother method. If there is a change of the Loan Servicer, Borrower-will be given written notice of the change in accordance with paragraph#14 above and applicable law. The notice will state the name and address of the new Loan-Servicer and the address to which payments should be made. The notice will

also contain any other information required by applicable law.

20. Hazardous Substances: Borrower shall not cause or permit the presence, use, disposal, storage, or release of any Hazardous Substances on or in the Property. Borrower shall not do, nor allow anyone else to do; anything affecting the Property that is in violation of any Environmental Law. The preceding two sentences shall not apply to the presence, use, or storage on the Property of small quantities of Hazardous Substances that are generally recognized to be appropriate to normal

The notice shall further inform Borrower of the right to reinstate after receleration and the right to assert in the foreclosure proceeding the non-existence of a default or any other defense of for ower to acceleration and foreclosure. If the default is not cured on or before the date specified in the notice Lendor at its option may require immediate payment in full of all sums secured by this Security Instrument without further demand and may foreclose this Security Instrument by judicial proceeding: Eender shall be entitled to collect all expenses incurred in pursuing the remedies provided in this paragraph 21, including, but not limited to reasonable afterceys' fees and costs of title evidence.
