1. ASSIGNMENT. As security for the repayment of the promissory note described above and all other present and future obligations of Grantor or Borrower to Lender (whether for the same or different purposes than the promissory note); (together the "Obligations"), Grantor hereby assigns to Lender all of Grantor's title and interest as lessor in and to the lease(s) ("Lease") of the premises identified above under Address Of Real Property. 8. DEFAULT. In the event of any default under the terms of the promissory note, this Assignment or any other obligation of Grantor or Borrower to Lender whether contained herein or in any other document, Lender shall have the right to exercise its status as an assignee under this Assignment and take the following action without presentment, notice or demand of any kind:


