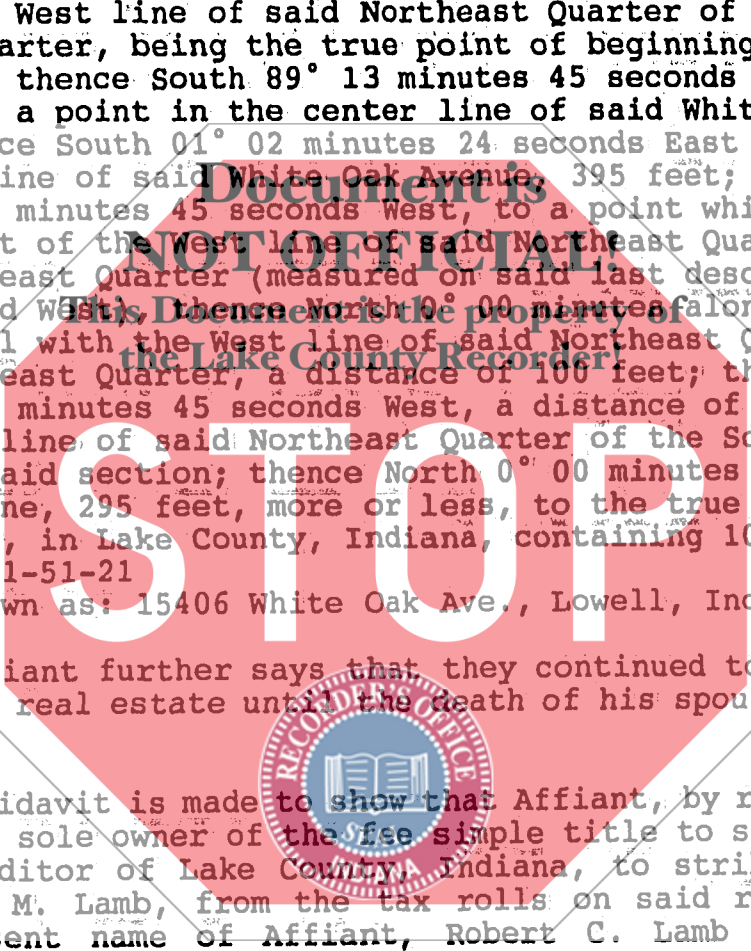
ROBERT C. LAMB, being first duly sworn upon his oath, deposes and says:

1. That he is of lawful age and lives and resides in the Town of Cedar Lake, Lake County, Indiana; that he was formerly married to one, *JEANNE M. LAMB, for many years and lived continuously with her as her husband until her death in Lake County, Indiana, on September 24, 1992. * a/k/a JEANNE LAMB

2. That several years last past, Affiant and his said spouse became the owners, of the fee simple title as tenants by the entirety, to the following described real estate, in Lake County, Indiana, to-wit:
