

TAX TITLE DEED TO COUNTY

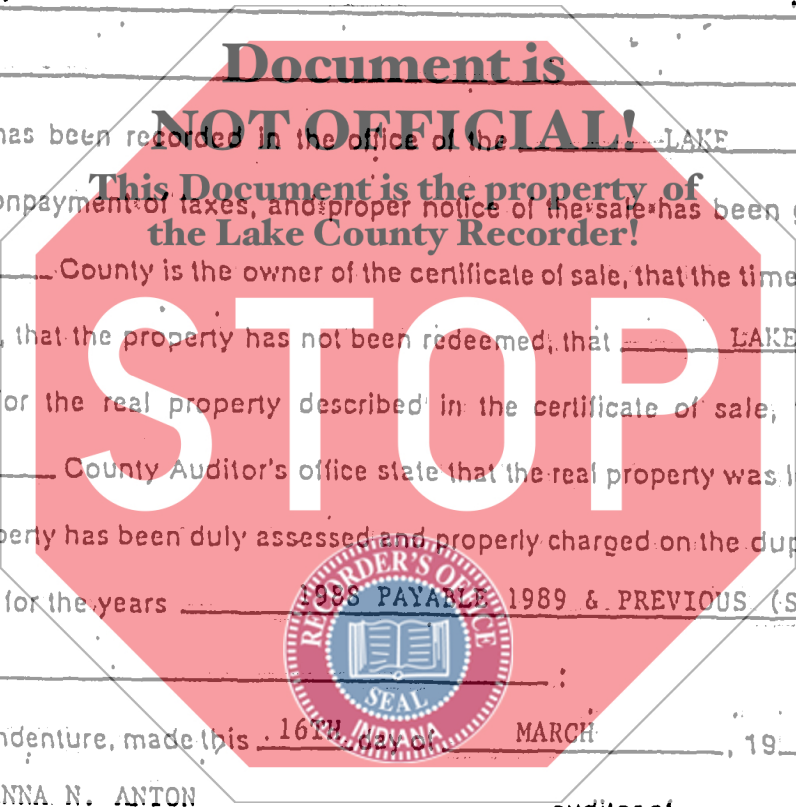
WHEREAS, 93016691 LAKE

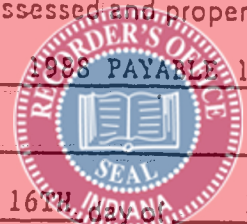
being the amount due on the real property for taxes, special assessments, penalties and costs for the years 1988 PAYABLE 1989 & PREVIOUS, namely:

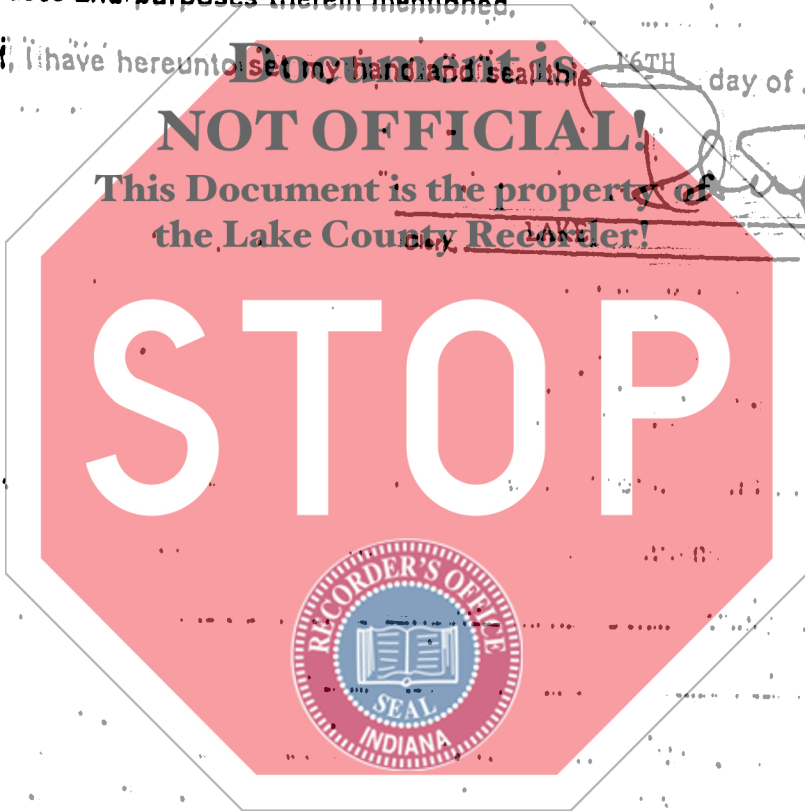

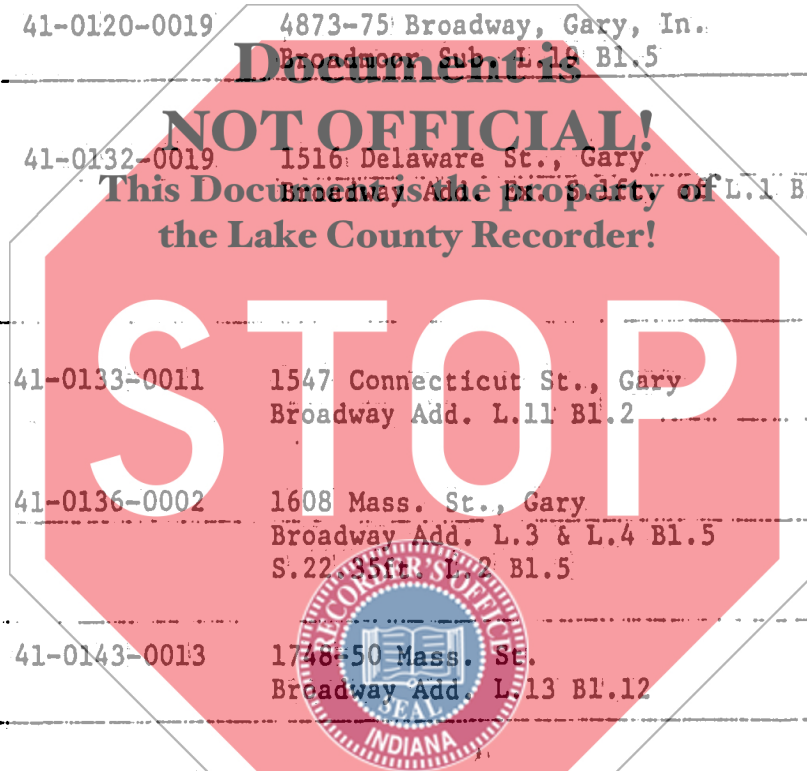

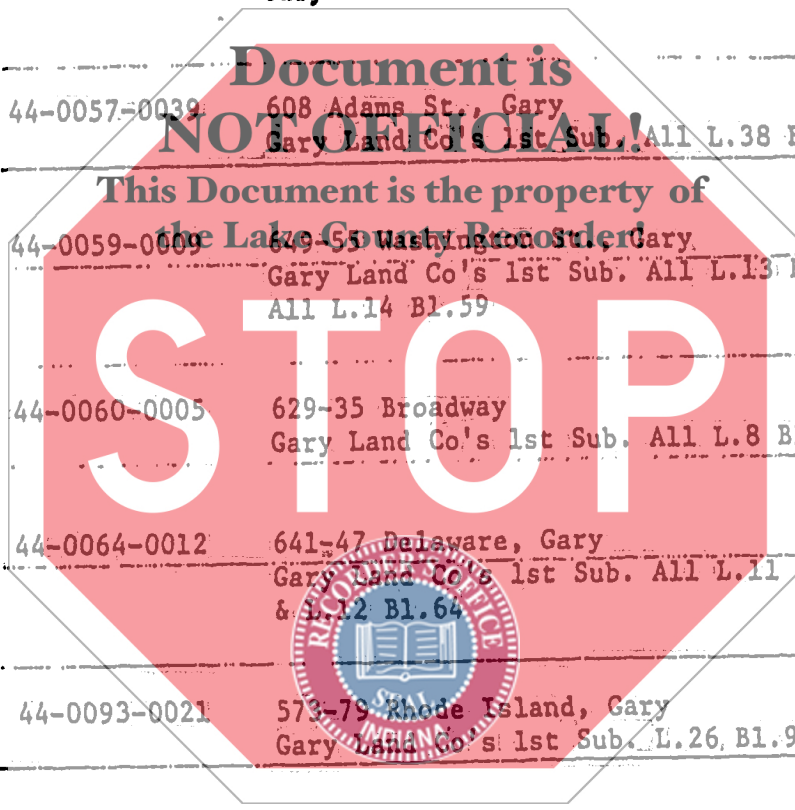
