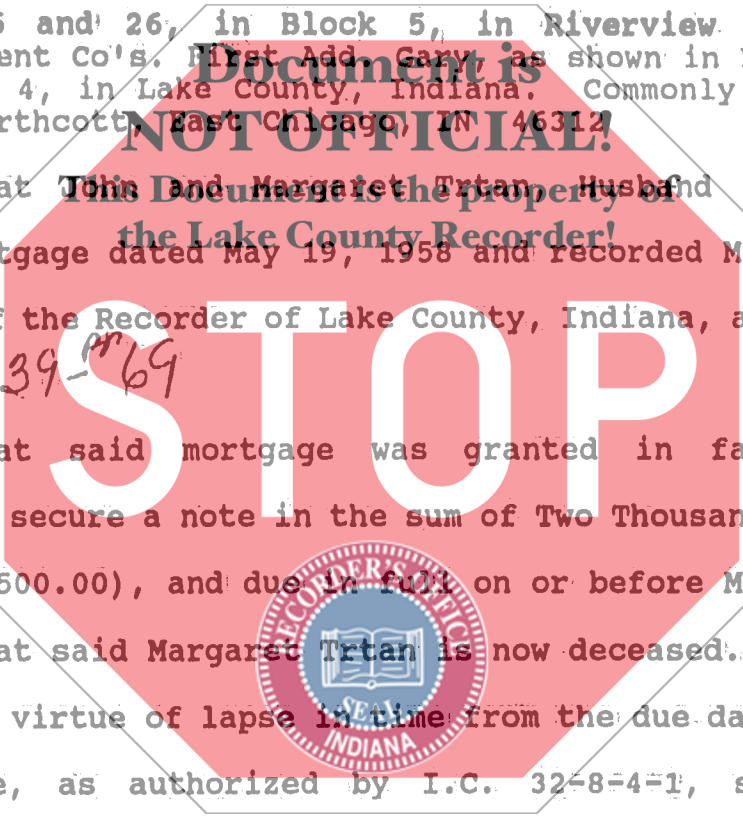
4. That said Margaret Trtan is now deceased.
