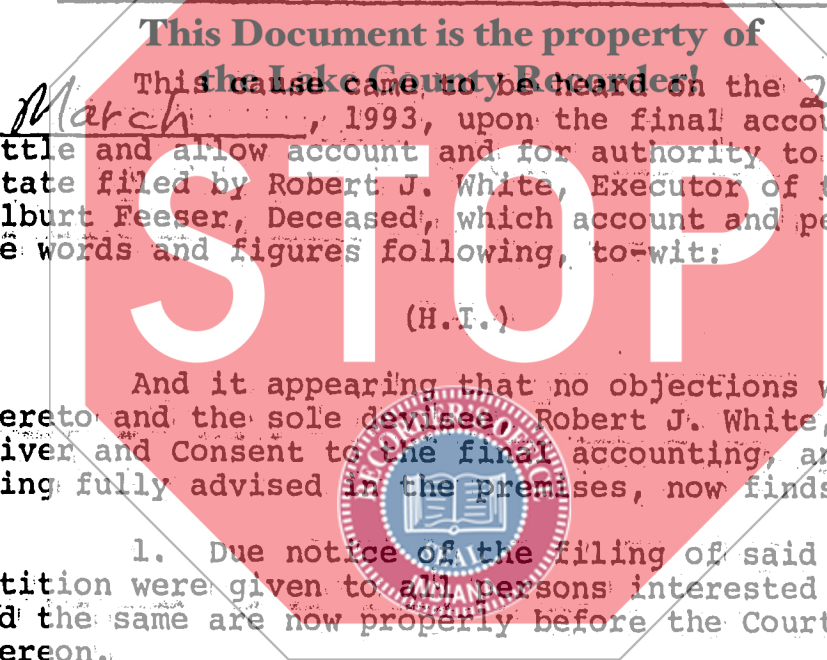

This cause came to be heard on the 2nd day of
March, 1993, upon the final account, petition to
settle and allow account and for authority to distribute
estate filed by Robert J. White, Executor of the Estate of
Wilburt Feeser, Deceased, which account and petition are in

And it appearing that no objections were filed
thereto and the sole devisee, Robert J. White, has filed his
Waiver and Consent to the final accounting, and the Court
being fully advised in the premises, now finds that:

1. Due notice of the filing of said account and
petition were given to all persons interested in said estate,
and the same are now properly before the Court for final action
thereon.
2. That Wilburt Feeser died testate, a resident of
the County of Lake, State of Indiana, on the 1st day of
January, 1991, and his Last Will and Testament was duly
admitted to probate before this Court on the 11th day of
January, 1991, and this Court appointed said Robert J. White
as Executor of the Last Will and Testament of the decedent, and
said Executor was issued Letters Teatamentary on the 11th day
of January, 1991, and since that date, he has continued to
serve in such capacity.

3. That the matters and things stated in said account and petition are true and that said Executor has accounted for all of the assets in this estate coming into his hands.

4. More than five months have elapsed since the date of the first published notice to legatees, devisees, and creditors of said decedent; all claims filed against said estate have been paid and discharged; neither said decedent nor his Executor were employers of labor within the meaning of that term as used in the Indiana Employment Security Act; all estate taxes, inheritance taxes and gross income taxes, if any, assessed in said estate have been paid.

5. The following is the sole devisee under the decedent's Last Will and Testament: Robert J. White, 100%, and that all assets and property of this estate remaining after payment of decedent's debts and expenses of administration has been distributed to the above-named person, as evidenced by his receipt, which is attached hereto and made a part of this accounting.

6. That the decedent owned a certain piece of real estate located at 301 Sherman Street, in the County of Lake, State of Indiana, more particularly described as follows:

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED BY THE COURT as follows:

1. Said Final Report and Account of said Executor is hereby in all things approved, settled and confirmed.
2. That the distribution of the balance of the property remaining in said Executor's hands for distribution has been made pursuant to the distribution set forth in the final accounting as prescribed under the Last Will and Testament of said decedent and is hereby in all things approved.

3. That pursuant to the decedent's Last Will and Testament, the following described real estate, to-wit:

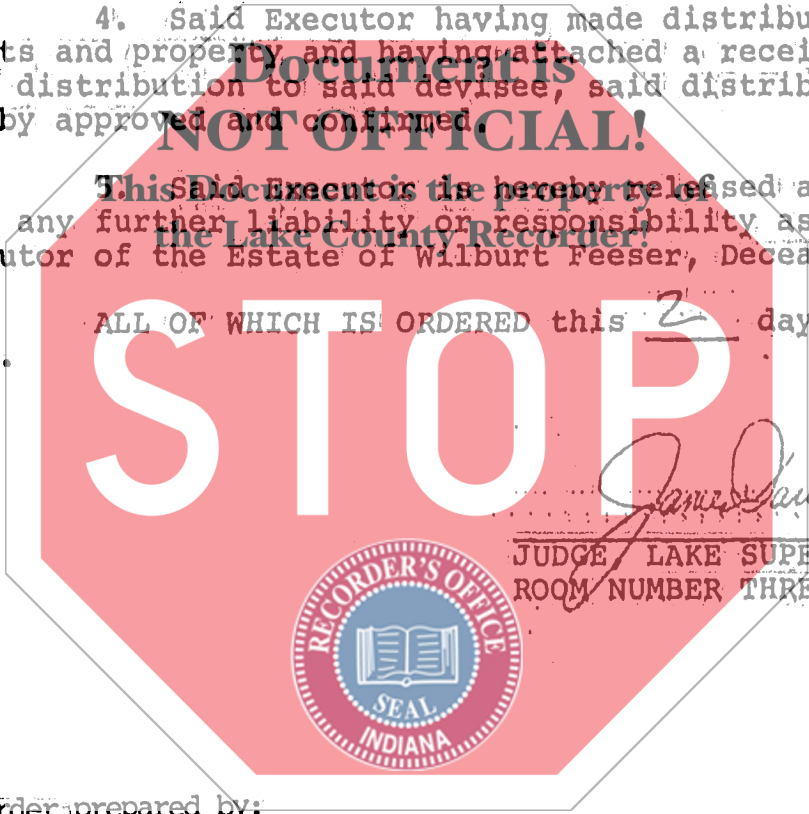
