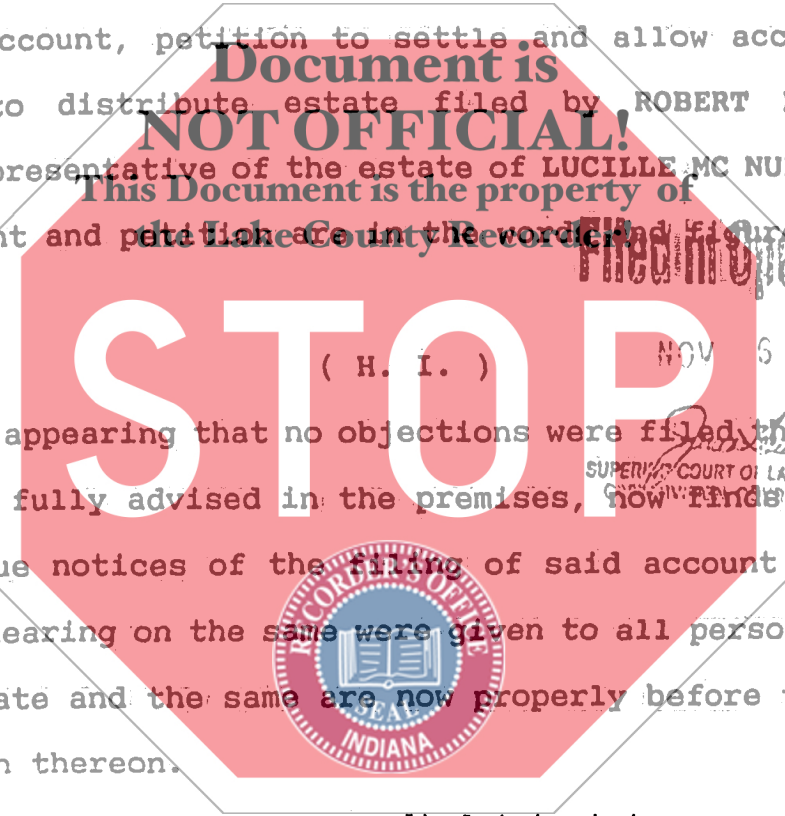

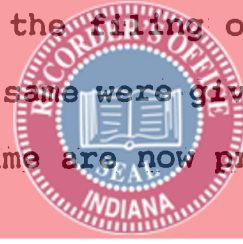
And it appearing that no objections were filed thereon and the Court being fully advised in the premises, now finds that

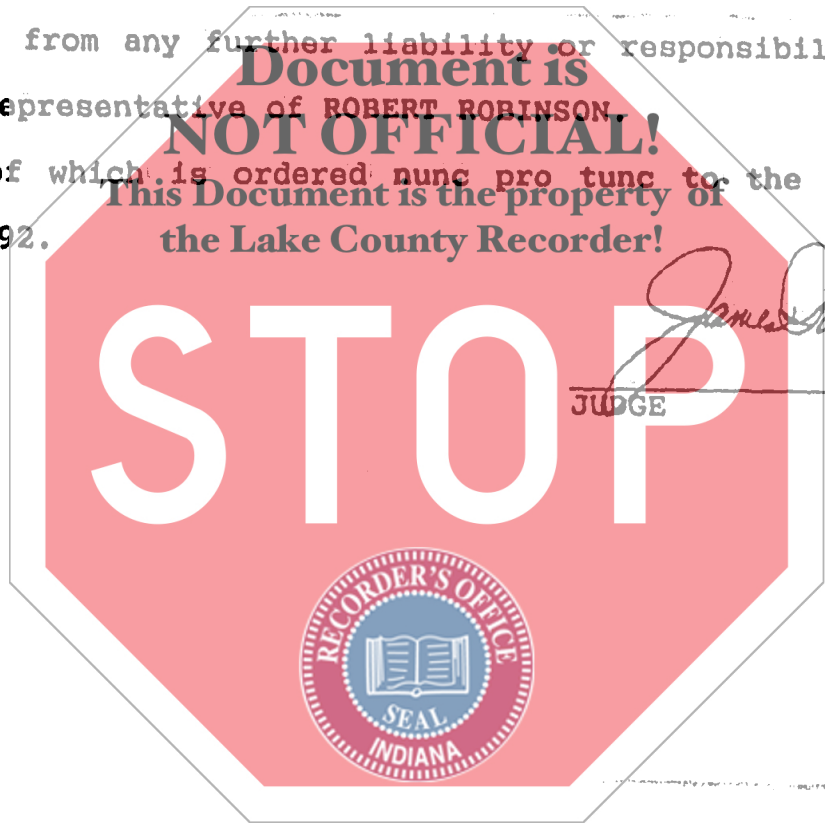
is hereby vested in ROBERT ROBINSON pursuant to the provisions of
