

LAST WILL AND TESTAMENT

KNOW ALL MEN BY THESE PRESENTS: That I, JAMES D. SAUTTER, of the City/Town of CROWN POINT, County of LAKE and State of INDIANA, being of sound and disposing mind and memory, do make, publish and declare the following to be my LAST WILL AND TESTAMENT, hereby revoking all Wills by me at any time heretofore made.

FIRST: I direct my Executor/Executrix, hereinafter named, to pay all my funeral expenses, administration expenses of my estate, including inheritance and succession taxes, state or federal, which may be occasioned by the passage of or succession to any interest in my estate under the terms of either this instrument or a separate inter vivos trust instrument, and all my just debts, excepting mortgage notes secured by mortgages upon real estate.

SECOND: I give, devise and bequeath to: LINDA A. SAUTTER, all my personal effects, such as jewelry, mementos, clothing, furniture, automobiles and similar items of a like nature, excluding, however, any stocks, bonds, cash or real estate.

THIRD: All the rest, residue and remainder of my estate, both real and personal, of whatsoever kind or character and wheresoever situated, I give, devise and bequeath to LINDA A. SAUTTER, of the City/Town of CROWN POINT, and State of INDIANA, as trustee, under the terms of a certain Trust executed by me, JAMES D. SAUTTER as of December 23, 1989, and already in existence, and I specifically direct and provide that the property received by virtue of this bequest shall be held by said Trustee, to be administered in accordance with the provisions thereof, as an addition to the Trust Fund, and said Trustee shall dispose of said property as a part of said Trust in accordance with the provisions thereof.

FOURTH: In the event that my spouse does not survive me, I request that

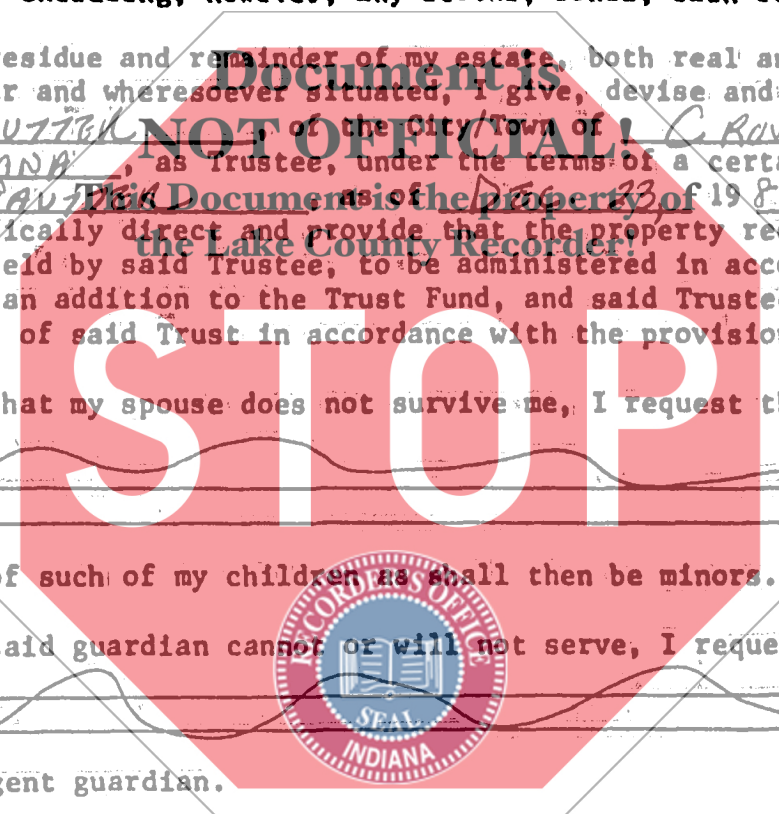
