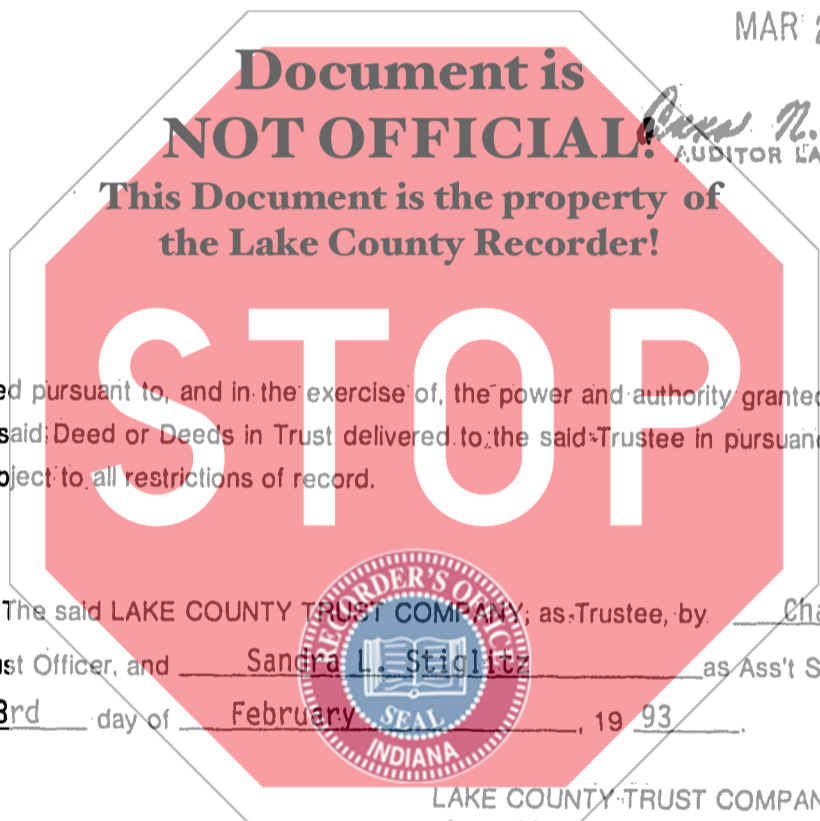

A part of the East Half of Section 13, Township 35 North, Range 9 West of the 2nd Principal Meridian, more particularly described as follows: Beginning at the Northeast corner of said Section 13; thence South 0 degrees, 13 minutes 21 seconds East, along the East line of said Section 13, a distance of 2659.52 feet to the centerline of Joliet Street (also known as 73rd Avenue); thence North 89 degrees 47 minutes 06 seconds West, along said centerline, a distance of 14.38 feet to a point of curve; thence Northwesterly, along said centerline and along a curve concave to the Southwest with a radius of 4182.14 feet and a chord that bears North 89 degrees 11 minutes 01 seconds West, a distance of 199.51 feet, an arc distance of 199.53 feet; thence South 89 degrees 26 minutes 58 seconds West, along said centerline, a distance of 356.14 feet; thence North 00 degrees 13 minutes 21 seconds West, parallel to the East line of said Section 13, a distance of 877.84 feet; thence South 89 degrees 46 minutes 39 seconds West, at right angles to the last described line, a distance of 360.00 feet; thence South 00 degrees 13 minutes 21 seconds East, parallel to the East line of said Section 13, a distance of 600.00 feet; thence North 89 degrees 46 minutes 39 seconds East, at right angles to the last described line, a distance of 108.80 feet; thence South 00 degrees 13 minutes 21 seconds East, parallel with the East line of said Section 13, a distance of 277.68 feet to the centerline of said Joliet Street; thence Northwesterly, along said centerline and along a curve concave to the Northeast with a radius of 978.63 feet and a chord that bears North 75 degrees 11 minutes 37 seconds West, a distance of 409.65 feet, an arc distance of 412.70 feet; thence North 63 degrees 06 minutes 45 seconds West, along said centerline, a distance of 120.28 feet; thence North 00 degrees 11 minutes 40 seconds West, along the West line of the East Half of the Northeast Quarter of said Section 13, a distance of 2485.29 feet to the North line of said Section 13, thence North 89 degrees 17 minutes 08 seconds East, along said North line, a distance of 1322.73 feet to the point of beginning, in the Town of Schererville, Lake County, Indiana.
