The term of this bond is for a period commencing March 17, 1993 and terminating March 17, 1994 and may be continued from year to year by continuation certificate executed by said Surety.

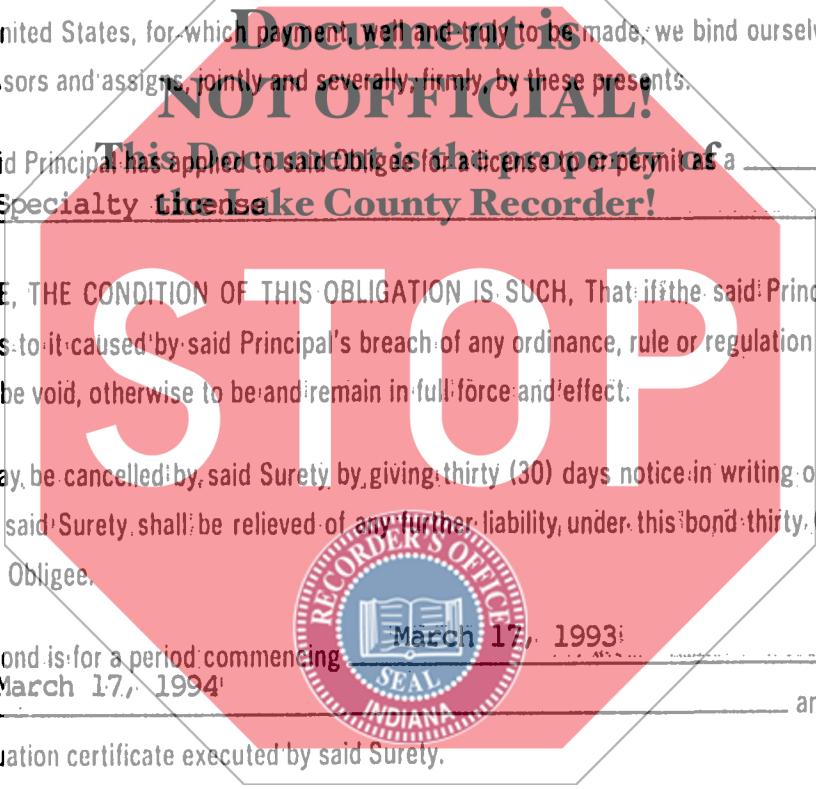
