MEMORANDUM OF AGREEMENT FOR CONTRACT FOR  
CONDITIONAL SALE OF REAL ESTATE

THIS MEMORANDUM AGREEMENT FOR CONTRACT FOR CONDITIONAL SALE OF REAL ESTATE, dated as of the 10th day of March, 1993, between ANNE M. KOKOTOVIC a/k/a ANNE M. KOLCOT a/k/a ANN M. KOKOT (hereinafter "Seller") and ROBERT A. BELCHER and ALMA R. BELCHER, husband and wife (hereinafter "Buyer").

Subject to the terms and conditions referred to below, Buyer agrees to purchase from Seller the land located at 8318 Kraay, Munster, Lake County, Indiana, together with all buildings and improvements thereon, which land is legally described as follows:

Lot 13 and the South half of Lot 14, in Block 2, in Kraay's Ridgeway Addition to the Town of Munster, as per plat thereof, recorded in Plat Book 34, page 24, in the Office of the Recorder of Lake County, Indiana (Key No. 28-116-13)

The terms and conditions (including the purchase price) of such Agreement are set forth in the Contract For Conditional Sale of Real Estate, dated March 10, 1993, between Seller and Buyer and are incorporated herein by reference with the same force and effect as though fully set forth herein. Title to said land will be conveyed to the Buyer upon completion of all the terms, provisions and covenants contained in said Contract For Conditional Sale of Real Estate.

The purpose of this Memorandum of Agreement For Contract For Conditional Sale of Real Estate is to give notice of the existence of such Contract For Conditional Sale of Real Estate which, together with this Memorandum, constitute the Agreement between Seller and Buyer.
