DEED IN TRUST

THIS INDENTURE WITNESSETH, that the Grantors, JOSEPH SERA and ISABELLE SERA a/k/a ISABELLA M. In no case shall any party dealing with the Trustee or any successor in trust, in relation to the real estate, or to whom the real estate or any part thereof shall be conveyed, contracted to be sold, leased or mortgages by the Trustee, or any successor in truste be obliged to see to the application of any purchase money rent or money borrowed or advanced on the real estate, or be obliged to see that the terms of this frust have been complied with or be obliged to inquire into the authority, necessity or expediency of any act of the thrustles County Robbided! or privileged to inquire into any of the terms of the Trust Agreement; and every deed, trust deed, mortgage, lease or other instrument executed by the Trustee, or any successor in trust in relation to the real estate shall be conclusive evidence in favor of every person (including the Registrar of Title of the County) relying upon or claiming under any such conveyance, lease or other instrument, (a) that at the time of the delivery thereof, the Trust created by this Indenture and by the Trust Agreement was in full force and effect, (b) that such conveyance or other instrument was executed in accordance with the trusts, conditions and limitations contained in this Indenture and in the Trust Agreement or in all amendments thereof, if any, and binding upon all beneficiaries thereunder, (c) that the Trustee, or any successor in trust was daily authorized and empowered to execute and deliver every such deed, trust deed, lease, mortgage or other instrument and (d) if the conveyance is made to a successor or successors in trust, that such successor or successors in trust have been properly appointed and are fully vested with all the title, estate, rights, powers, authorities, duties and obligations of its, his or their predecessor in trust.

This conveyance is made upon the express understanding and condition that JOSEPH J. SERA and ISABELLA M. SERA as Trustees, or their successor or successors in trust shall incur any personal liability or be subjected to any claim, judgment or decree for anything she or her agents or attorneys may do or omit to do in or about the real estate or under the provisions of this Deed or the Trust Agreement or any amendment thereto, or for injury to person or property happening in or about the real estate, any and all

such liability being hereby expressly waived and released. Any contract obligation or indebtedness incurred or entered into by the Trustee in connection with the real estate may be entered into in the name of the then beneficiaries under the Trust Agreement as their attorney in fact, hereby irrevocably appointed for such purposes, or at the election of the Trustee, in her own name, as Trustee of an express trust and not individually (and the Trustee shall have no obligation whatsoever, with respect to any such contract, obligation or indebtedness, except only so far as the Trustee shall be applicable for the payment and discharge thereof). All persons and corporations whomsoever and whatsoever shall be charged with notice of this condition from the date of the filing for record of this Deed.

The interest of each land Cevery Speneficiary hereunder and under the frust Agreement and of all persons claiming under them or any of them shall be Anly in the earnings, avails and proceeds arising from the sale or any other disposition of the real estate, and such interest in hereby declared to beth personal our proceeds and such interest in hereby hereunder shall have any title or interest, legal or equitable, in or to the real estate as such, but only an interest in the earnings, avails and proceeds thereof as aforesaid, the intention hereof being to vest in JOSEPH J. SERA and ISABELLA M. SERA, as Trustees, the entire legal and equitable title in fee simple, in and to all of the real estate above described.

In the event that JOSEPH J. SERA and ISABELLA M. SERA are incapacitated and unable to manage their affairs, as determined in accordance with the terms and conditions of the Trust Agreement, or bron the death of JOSEPH J. SERA and ISABELLA M. SERA, then and in such event, IRENE A. CLARK, shall serve as Successor Trustee. In the event that IRENE A. CLARK refuses to act as Trustee, or shall die, or disqualify for any reason, then RICHARD A. CLARK shall serve as Successor Trustee. In the event that RICHARD A. CLARK, shall refuse to act as Trustee, or shall die, or disqualify for any reason, then RONALD A. CLARK, shall serve as Successor Trustee. The Successor Trustee shall have all of the duties, rights, titles and powers, whether discretionary or otherwise, as the Trustee has hereunder.
