them at the Political Subdivision named herein, and at the expiration of thirty-five (35) days from the mail-
ing of said notice, this bond shall ipso facto terminate and the Surety shall thereupon be relieved from any lia-
bility for any acts or omissions of the Principal subsequent to said date.

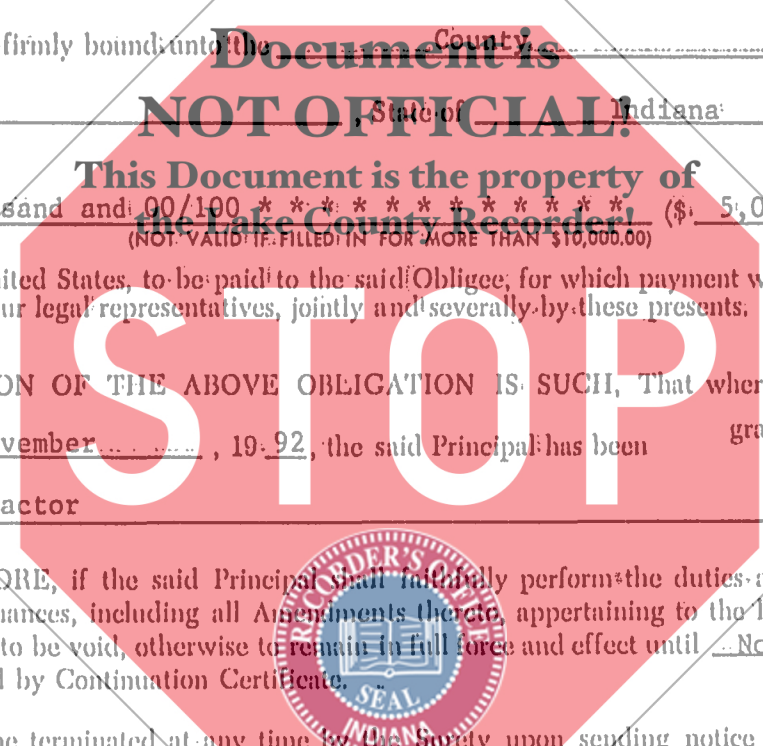

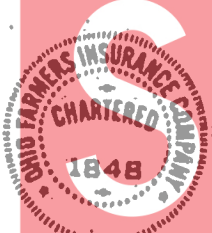

(Adopted at a meeting held on the 13th day of July, 1976.) 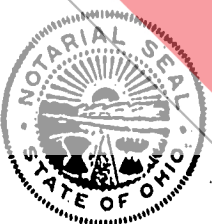
