being fully advised in the premises, now makes the following findings:

a. Due notices of the filing of the Final Account and Petitions and of this hearing

were given to all persons interested in the Estate, and the same are now properly before the  
Court for final action.

b. The decedent MARY STEPANOVICH died testate, a resident of Lake County,  
Indiana, on the 23rd day of January, 1992 and her Last Will and Testament was duly  
admitted to probate before this Court on the 7th day of February, 1992.

c. On the 7th day of February, 1992, NATALIE VUJOVICH was appointed Personal Representative of the decedent's Estate and she has continued to serve in such capacity.

d. The matters stated in the Final Account and Petitions are true and the Personal Representative has accounted for all the Estate's assets.

e. More than five months have elapsed since the date of the first published notice to legatees, devisees and creditors of the decedent and all claims filed against this Estate have been paid and discharged.

f. Neither the decedent nor the Personal Representative were employers of labor as defined by the Indiana Employment Security Act and all estate taxes, inheritance taxes and gross income taxes, if any were assessed in this Estate, have been paid.

g. The decedent owned the following interests in real estate at the time of her death:

Lot 32 in Prairie Park Unit 2 in the City of East Chicago as per plat thereof, recorded in Plat Book 35, page 77 in the Office of the Recorder of Lake County, Indiana, commonly known as 4206 Hidalgo Lane, East Chicago, IN.

According to the decedent's Will this real estate is devised to the remaindermen, namely: NATALIE VUJOVICH, DAVID S. STEVENS, DAWN KRSTICH and DONALD STEPANOVICH, as tenants in common.

h. In addition to the aforementioned devisees, the decedent left Two Thousand Dollars (\$2,000.00) to her sister DOROTHY DOYICH and Five Thousand Dollars

(\$5,000.00) each to her grandchildren MARIA PAVKOVICH, LISA VARNUM, DAWN RADICH, DANIELLE KRSTICH and LANA KRSTICH.

The decedent directed that the remainder of the Estate be disposed of in equal shares to the aforementioned remaindermen.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED THAT:

1. The Final Account is approved and confirmed and the attendant Petitions are granted.

2. Pursuant to the decedent's Last Will and Testament the following described real estate is hereby vested as follows:

Lot 32 in Prairie Park Unit 2 in the City of East Chicago as per plat thereof, recorded in Plat Book 35, page 77 in the Office of the Recorder of Lake County, Indiana, commonly known as 4206 Hidalgo Lane, East Chicago, IN,

in the names of NATALIE VUJOVICH, DAVID S. STEVENS, DAWN KRSTICH and DONALD STEPANOVICH, as tenants in common.


3. The Personal Representative is hereby directed to procure a Certified Copy of this decree and record it in the Recorder's Office of Lake County.

4. Pursuant to the provisions in the decedent's Last Will and Testament, Personal Representative is hereby directed to make distribution of the balance of assets remaining in the Estate as follows:

Two Thousand Dollars (\$2,000.00) to DOROTHY DOYICH. Five Thousand Dollars (\$5,000.00) each to MARIA PAVKOVICH, LISA VARNUM, DAWN RADICH, DANIELLE KRSTICH and LANA KRSTICH. The remainder is given in equal shares to NATALIE VUJOVICH, DAVID S. STEVENS, DAWN KRSTICH and DONALD STEPANOVICH.

5. The Personal Representative is directed to file a supplemental report showing that she has complied with the terms of this Order.

All of which is ordered this 12th day of February 1993.


