DECLARATION OF TRUST

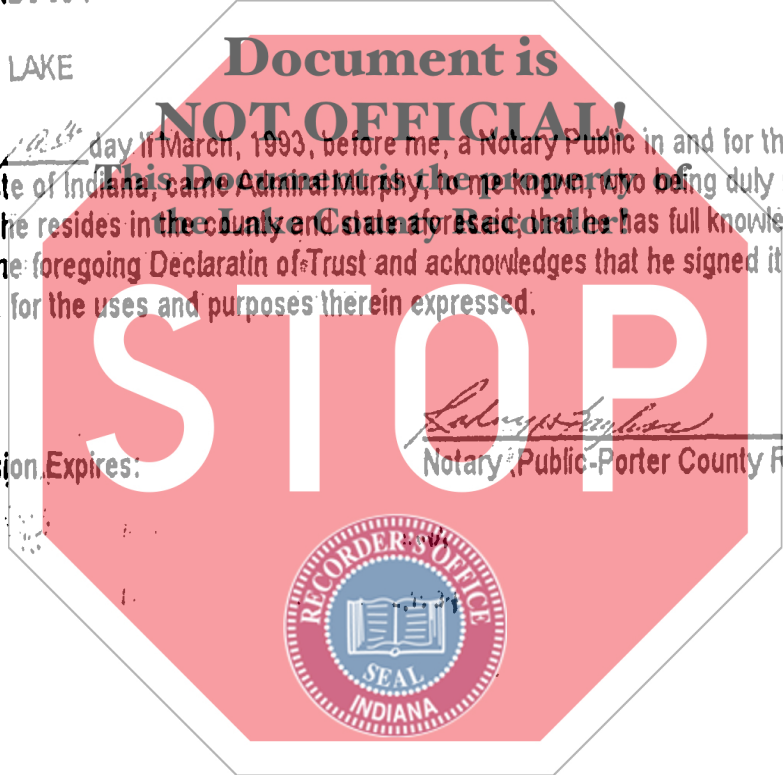

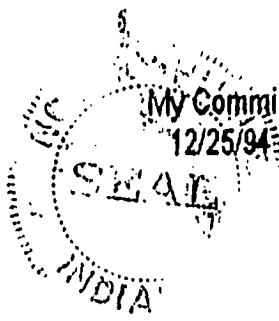
