**AFFIDAVIT OF SURVIVORSHIP**

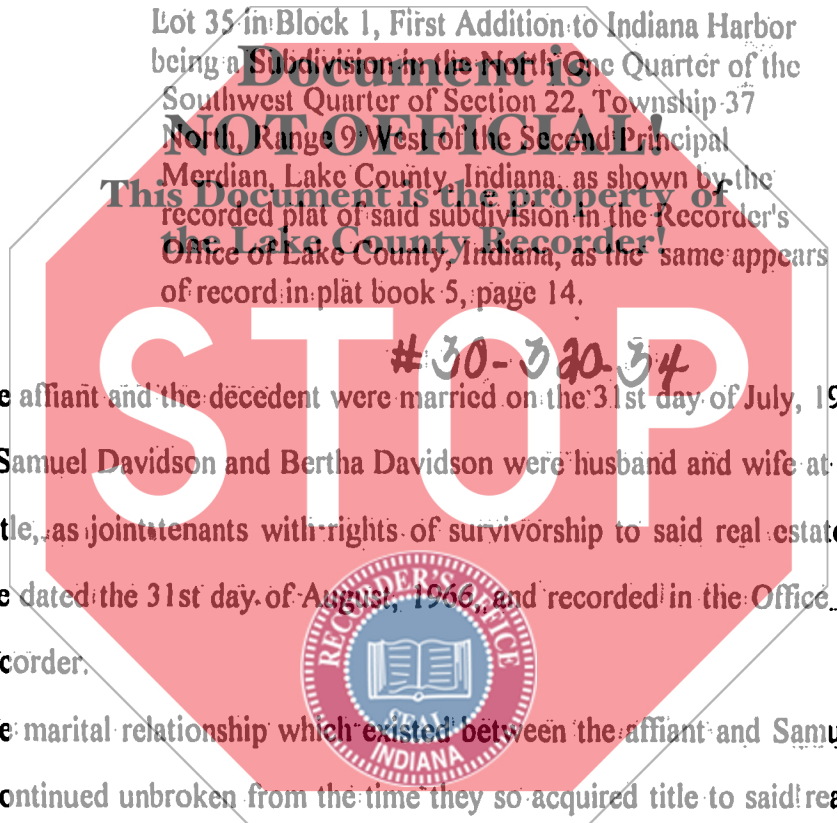
Comes now Bertha Davidson, being duly sworn upon her oath and states as follows:

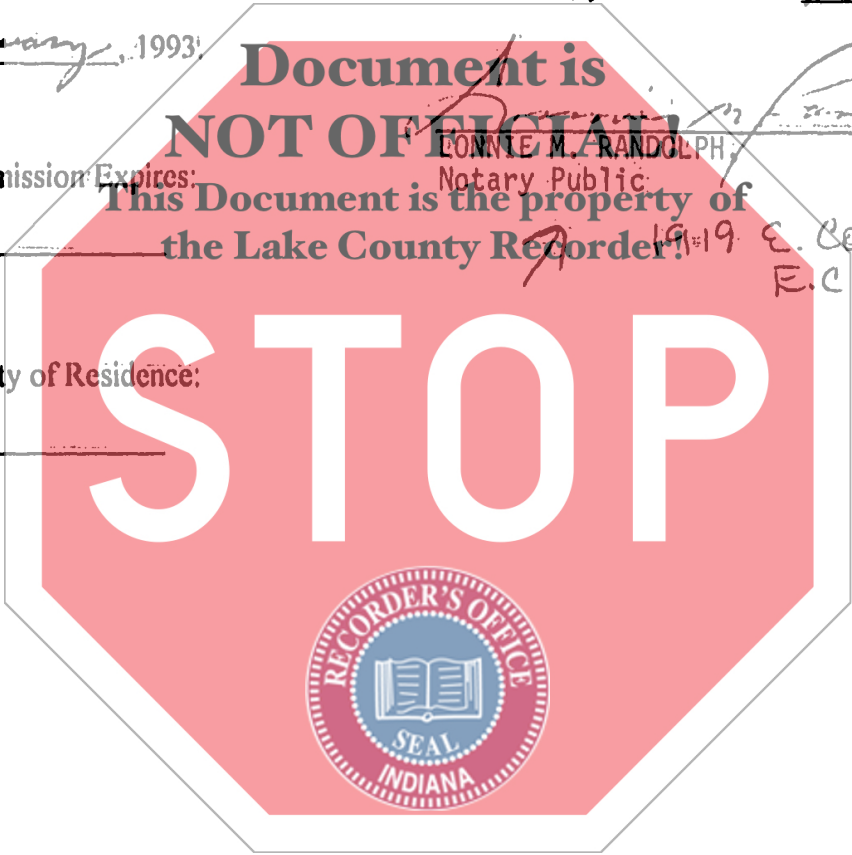
