AFFIDAVIT OF SURVIVORSHIP

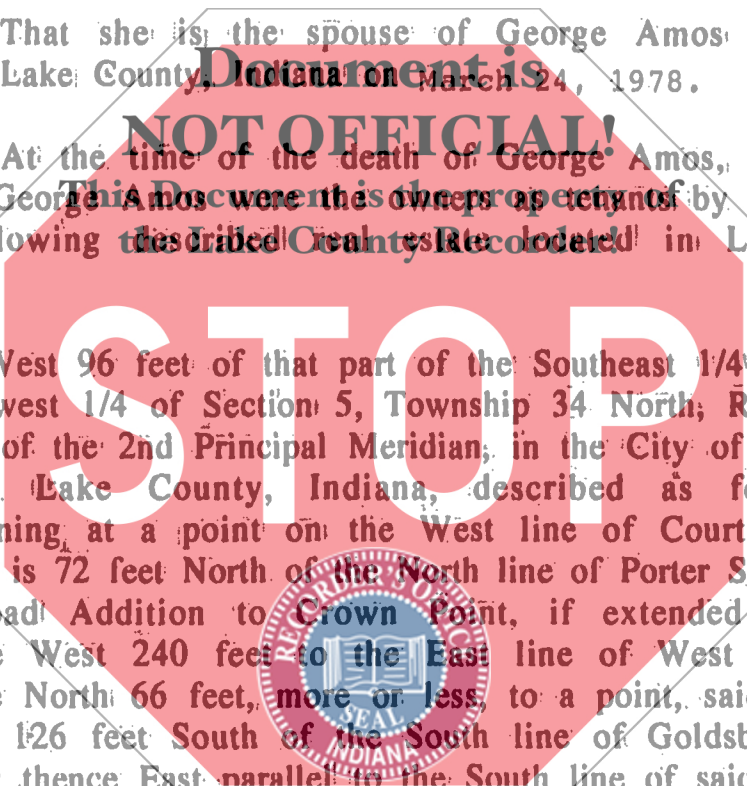
GRACE LUCILE AMOS, being first duly sworn upon his oath, states as follows:
