Assignee hereby accepts this Assignment of Right of Way Easement and agrees to keep and perform all the conditions and covenants in each Right of Way required to be kept and performed by TPI from and after the effective date of this Assignment.

Assignee hereby waives any prior breaches, defaults, failures of performance or obligations under the Right of Way occurring prior to this Assignment and hereby expressly waives any right to proceed against TPL for said defaults, breaches, failures of performance or obligations.

This Assignment shall be binding upon, and inure to the benefit of TPL and Assignee, and their respective successors and assigns.

This Assignment has been executed on the date of the acknowledgement hereto-but shall be effective for all purposes as of April 1993.
