WARRANTY DEED

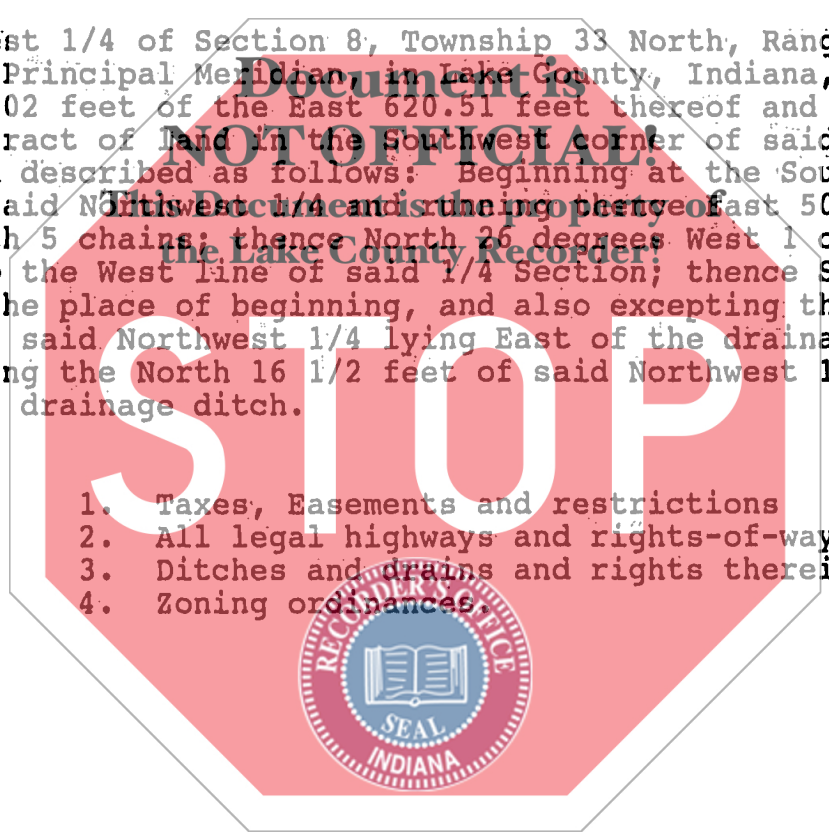
