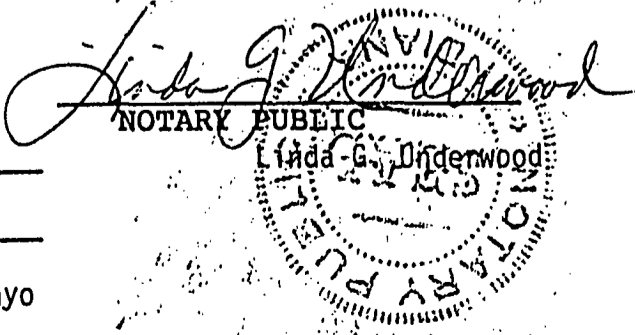

LEGAL DESCRIPTION:

Part of the West 1/2 of the Northwest 1/4 of Section 21, Township 36 North, Range 7 West of the 2nd Principal Meridian, in the City of Lake Station, in Lake County, Indiana, lying Northerly and Westerly of Deep River, described as follows: Commencing at the point of intersection of the North line of the Northwest 1/4 of said Section 21 with the East right of way line of State Road #51, which point is 60 feet East of the Northwest corner of said Section 21, thence South along said East right of way line and parallel to the West line of said Section 21, a distance of 427 feet to the point of beginning of the parcel herein described; thence East and parallel to the North line of the Northwest 1/4 of said Section 21, a distance of 680 feet more or less, to the edge of Deep River; thence Southerly along the edge of Deep River to a point on a line which is 127 feet South of the first described line; thence West and parallel to the North line of the Northwest 1/4 of said Section 21, a distance of 700 feet, more or less, to the East right of way line of State Road #51; thence North, along the said East right of way line a distance of 127 feet to the place of beginning.
