1. Due notices of the filing of said account and petition and of the hearing on the same were given to persons interested in said estate.

2. That John Kolas died testate, a resident of County of Lake, State of Indiana, on the 21st day of June, 1986, and his last Will and Testament was duly admitted to Probate on the 19th day of August, 1986, said executor was issued Letters Testamentary on the 5th day of September, 1986, and since that date has continued to serve in such capacity.

3. That the matters and things stated in said account and petition are true, and that said executor has accounted for all assets in said estate coming into its possession.

4. More than five (5) months have elapsed since the date of the first published notice to legatees, devisees, and creditors of said decedent; all claims filed against the estate have been paid and discharged; neither said decedent nor his executor was an employer of labor within the meaning of that term as used in the Indiana Employment Security Act; all estate taxes, inheritance taxes, and gross income taxes if any assessed in said estate have been paid.


