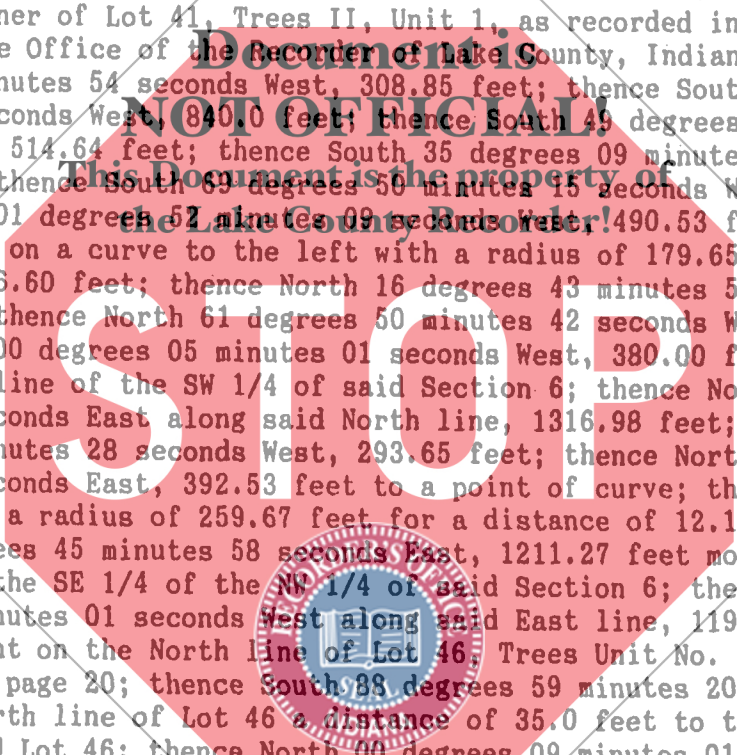
PARTIAL RELEASE OF REAL ESTATE MORTGAGE

KNOW ALL MEN BY THESE PRESENTS: That Farm Credit Services of Mid-America, ACA, a corporation organized and existing under an Act of Congress known as the Farm Credit Act of 1971, as amended, the owner and holder of the mortgage described herein and of the debt secured thereby, for good and valuable consideration, the receipt of which is hereby acknowledged, does hereby remise, release and discharge from the lien of a certain real estate mortgage executed by Lawrence H. Part of the SW 1/4 and part of the NW 1/4 of Section 6, Township 34 North, Range 7 West of the 2nd P.M., described as follows: Commencing at the Southwest corner of Lot 41, Trees II, Unit 1, as recorded in Plat Book 73, page 9, in the Office of the Recorder of Lake County, Indiana; thence North 87 degrees 04 minutes 54 seconds West, 308.85 feet; thence South 89 degrees 10 minutes 44 seconds West, 840.0 feet; thence South 49 degrees 10 minutes 44 seconds West, 514.64 feet; thence South 35 degrees 09 minutes 45 seconds East, 225.62 feet; thence South 69 degrees 50 minutes 15 seconds West, 396.88 feet; thence North 01 degree 52 minutes 09 seconds West, 490.53 feet to a point of curve; thence on a curve to the left with a radius of 179.65 feet for a distance of 46.60 feet; thence North 16 degrees 43 minutes 54 seconds West, 311.58 feet; thence North 61 degrees 50 minutes 42 seconds West, 248.99 feet; thence North 00 degrees 05 minutes 01 seconds West, 380.00 feet more or less to the North line of the SW 1/4 of said Section 6; thence North 88 degrees 59 minutes 20 seconds East along said North line, 1316.98 feet; thence North 00 degrees 15 minutes 28 seconds West, 293.65 feet; thence North 56 degrees 26 minutes 59 seconds East, 392.53 feet to a point of curve; thence on a curve to the left with a radius of 259.67 feet for a distance of 12.16 feet; thence North 53 degrees 45 minutes 58 seconds East, 1211.27 feet more or less to the East line of the SE 1/4 of the NW 1/4 of said Section 6; thence South 00 degrees 09 minutes 01 seconds West along said East line, 1193.51 feet more or less to a point on the North line of Lot 46, Trees Unit No. 4, recorded in Plat Book 71, page 20; thence South 88 degrees 59 minutes 20 seconds West along said North line of Lot 46 a distance of 35.0 feet to the Northwest corner of said Lot 46; thence North 00 degrees 09 minutes 01 seconds East, 59.35 feet to the Northeast corner of Lot 1, Trees II, Unit No. 1; thence South 85 degrees 48 minutes 28 seconds West, 421.70 feet to a point of curve; thence South on a curve to the right with a radius of 392.13 feet a distance of 93.42 feet; thence South 79 degrees 59 minutes 19 seconds West, 295.0 feet; thence South 10 degrees 12 minutes 10 seconds West, 228.41 feet to a point of curve; thence East on a curve to the left with a radius of 416.53 feet a distance of 140.88 feet; thence South 09 degrees 10 minutes 35 seconds East, 351.85 feet more or less to the point of beginning, containing 55.34 acres more or less, in Lake County, Indiana.
