    - (b) fails to perform any Obligation or breaches any warranty or covenant to Lender contained in this Mortgage or any other present or future; written or oral, agreement;

    - (d) seeks to revoke, terminate or otherwise limit its liability under any guaranty to Lender;
    - (e) allows the Property to be used by anyone to transport or store goods the possession, transportation, or use of which, is illegal;
    - (f) causes Lender to deem itself insecure in good faith for any reason.
- 22. RIGHTS OF LENDER ON DEFAULT. If there is a default under this Mortgage, Lender shall be entitled to exercise one or more of the following remedies without notice or demand (except as required by law):
  - (a) to declare the Obligations immediately due and payable in full;
