Assignment of Mortgage

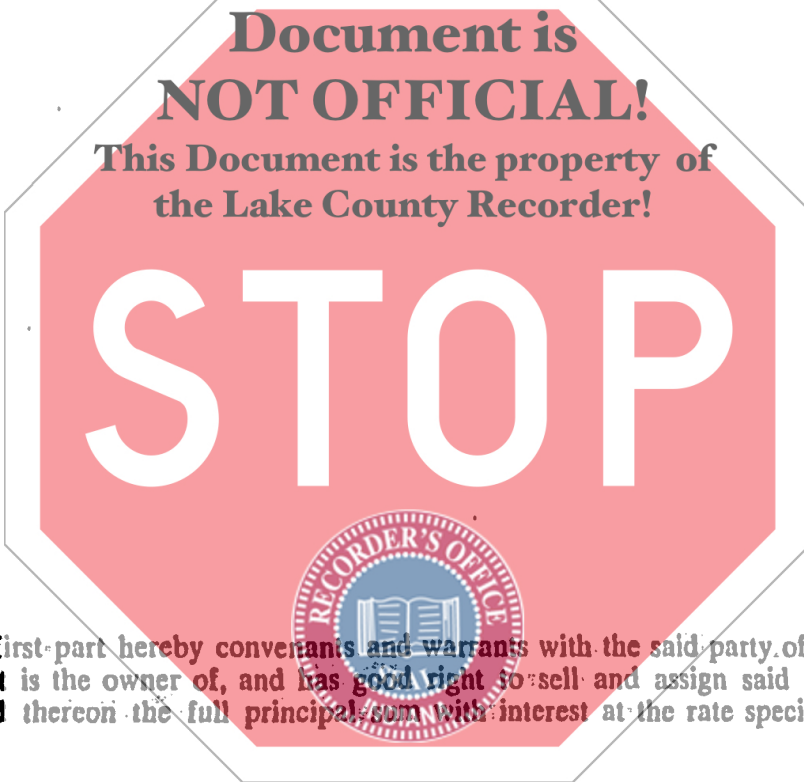
