

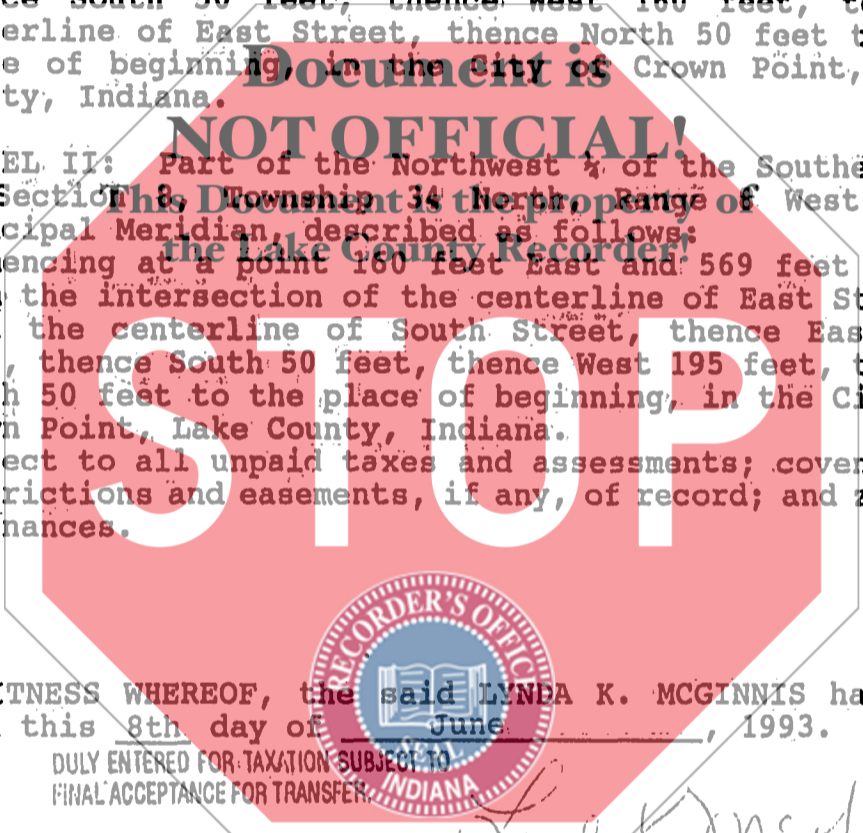

THIS INDENTURE WITNESSETH , That LYNDA K. MCGINNIS, of adult age, of Lake County, in the State of Indiana, QUITCLAIM(S) her interest in the real estate to DANIEL J. MCGINNIS, of adult age, of Lake County, State of Indiana, for the sum of One and No/100 (\$1.00) Dollars, and other valuable consideration, the receipt of which is hereby acknowledged, the following described real estate in Lake County, Indiana:

PARCEL I: Part of the Northwest 1/4 of the Southeast 1/4 of Section 8, Township 34 North, Range 8 West, of the 2nd Principal Meridian, described as follows: Commencing in the centerline of East Street at a point 569 feet South of the centerline of South Street, thence East 160 feet, thence South 50 feet, thence West 160 feet, to the centerline of East Street, thence North 50 feet to the place of beginning, in the City of Crown Point, Lake County, Indiana.

PARCEL II: Part of the Northwest 1/4 of the Southeast 1/4 of Section 8, Township 34 North, Range 8 West, 2nd Principal Meridian, described as follows: Commencing at a point 160 feet East and 569 feet South from the intersection of the centerline of East Street, with the centerline of South Street, thence East 195 feet, thence South 50 feet, thence West 195 feet, thence North 50 feet to the place of beginning, in the City of Crown Point, Lake County, Indiana. Subject to all unpaid taxes and assessments; covenants, restrictions and easements, if any, of record; and zoning ordinances.
