4. Affiant waives her right, title and interest in any and all other assets in the estate.

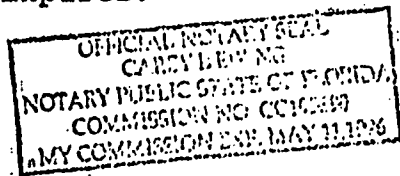
