It is my wish, and I hereby direct that all my just debts which I incur during my lifetime or am otherwise legally obligated to pay at the time of my death and are not barred by any statute of limitations or other defenses be paid as soon as practicable after my decease, together with my funeral and administrative expenses.

STOP

I hereby give, bequeath and devise any and all personal property I own at my death to my former wife, MARION A. KUECHENBERG and my nine children in equal shares. In the event that my former wife, MARION A. KUECHENBERG, does not survive me by thirty (30) days, her share of my estate shall be void and she takes nothing under this Will, and her share shall be given in equal shares to my children then living, or to the heirs of those who may not be living at the time of my death.

ARTICLE III

All the rest, residue and remainder of my property and estate which I own at the time of my demise, whether real, personal or mixed and wheresoever situate and including all lapsed, disclaimed and void gifts, I hereby give, devise and bequeath to my children in equal shares. If any of my children predecease me, the interest which would have passed to him is:

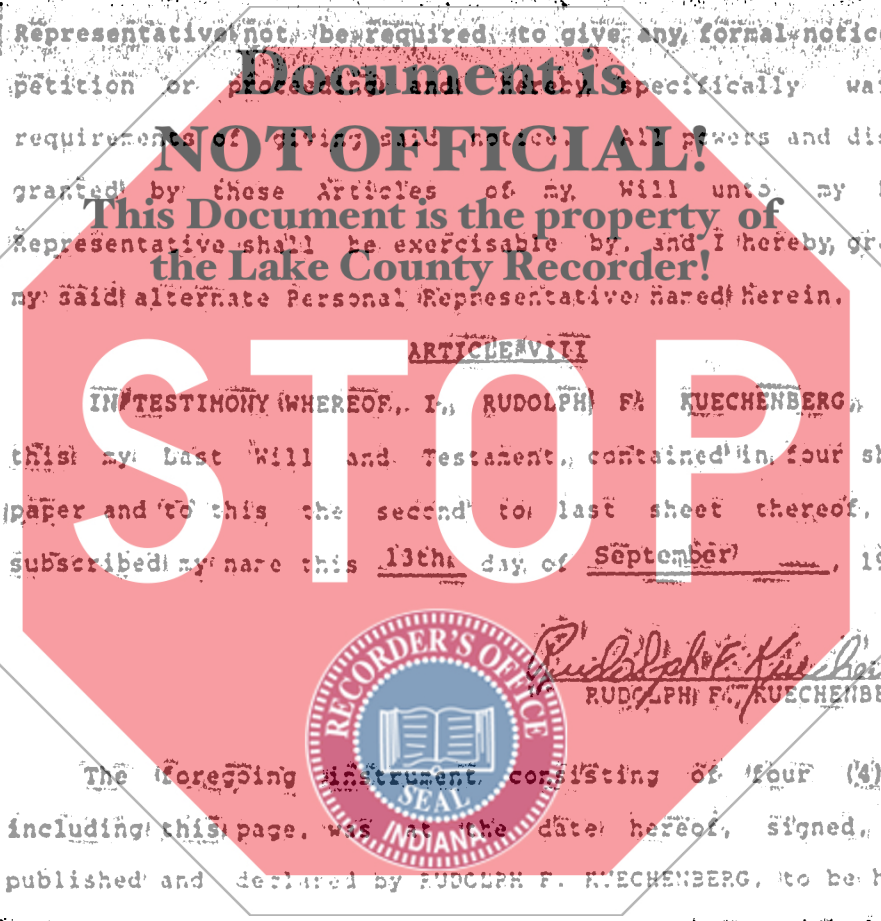

ARTICLE V

I hereby empower my Personal Representative to serve with full power and authority, without any Order of Court to sell, transfer and convey, all property, real, personal or mixed which is a part of my Estate at such time and price and upon such terms and conditions (including credit) as my said personal representative may deem advisable or proper for the preservation or improvement of the Estate, and without Order of Court to pay expenses that are reasonable in the judgment of my Personal Representative, for the delivery of gifts and to settle, compromise or adjust and claim or demand by or against my Estate and to agree to any rescission or modification of any contract or agreement, and to perform any other acts or things necessary or appropriate to the complete administration of this Will, granting my said Personal Representative any and all powers, discretion and authority conferred upon personal representatives by the laws of the Statutes of the State of Florida now or hereafter in force as of the date of my death. My Personal Representative is further empowered to pay all or any portion of administration

expenses, debts, or taxes out of income or principal and to accumulate the income of the Estate for this purpose. Unless otherwise provided by this instrument, the amounts paid from income shall be charges against income, and those payments shall require no reimbursements or adjustments of the accounts of the Estate or of the shares that the beneficiaries shall be entitled to receive in income or principal. I hereby specifically direct that my Personal Representative, and any alternate Personal Representative, not be required to give any formal notice of any petition or proceeding and hereby specifically waive the requirements of giving said notice. All powers and discretion granted by these Articles of my Will unto my Personal Representative shall be exercisable by, and I hereby grant unto my said alternate Personal Representative named herein.



ARTICLE VIII
