and other valuable consideration _____ the receipt of which is hereby acknowledged; the

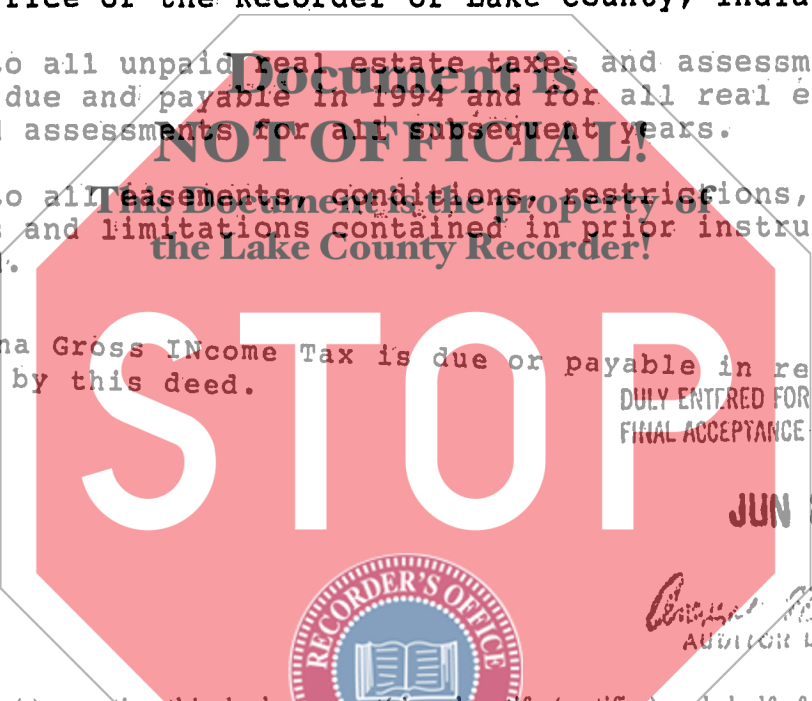
following described real estate in Lake County, in the State of Indiana, to-wit:

Subject to all unpaid real estate taxes and assessments for 1993 due and payable in 1994 and for all real estate taxes and assessments for all subsequent years.

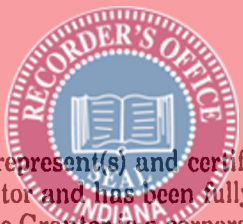
