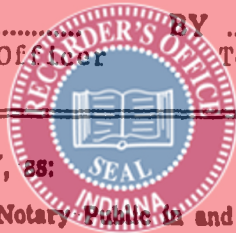

Addendum

Part of Lot 4, Block 1, Broadfield Townshomes addition, a subdivision of Tract D, Broadfield center, to the Town of Merrillville, as recorded in Plat Book 67, page 65, in the Office of the Recorder of Lake County, Indiana, which part of said lot 4 is more particularly described as follows: Commencing at the Southeast corner of said lot 4, thence West, along the South line of said Lot 4, a distance of 40.001 feet to the point of beginning; thence continuing West along the South line of said Lot 4 a distance of 28.001 feet; thence North, a line that is 68.000 feet West of and parallel to the East line of said Lot 4, a distance of 108.663 feet, thence North Easterly a distance of 34.908 feet to a point that lies on the curved northerly line of said Lot 4, said point lying an arc length of 55.376 feet Westerly of the Northeast corner of said Lot 4 on a curve concave to the North and having a radius of 50.004 feet; thence Southeasterly along said curved Northerly line an arc length of 16.069 feet; thence Southwesterly, along a line radial to said curve, a distance of 20.347 feet to a point that lies on a line that is 40.000 feet West of and parallel to the East line of said lot 4, thence South, along said parallel line a distance of 125.187 feet to the point of beginning, all in the Town of Merrillville, Lake County, Indiana.
