- 1. Mortgagor is the owner of sald premises in fee simple or such other estate as is stated herein.
- 2! Mortgagor will pay the indebtedness as provided in said note and this mortgage. Privilege is reserved to prepay at any time, without premium or fee, the entire indebtedness or any part thereof not less than the amount of one installment, or one hundred dollars (\$100,00), whichever is less. Any deficiency in the amount of such eggregate monthly payment shall, unless made good by the Mortgagor prior to the due date of the next such payment, constitute an event of default under this mortgage. At Mortgagee's option, Mortgagor will pay a "late charge" not exceeding four per centum (4%) of any installment when paid more than fifteen (15) days after the due date thereof to cover the extra expense involved in handling delinquent payments, but such "late charge" shall not be payable out of the proceeds of any sale made to satisfy the indebtedness secured hereby, unless such proceeds: are sufficient to discharge the entire indebtedness and all: proper costs and expenses secured thereby

- 4. If the total of the payments made by the Mortgager as trustee for ground rents, taxes or assessments or insurance premiums, as the case may be, such access shall be credited on subsequent payments to be made by the Mortgager for such items or, at Mortgager's cation, as trustee, shall be refunded to Mortgagor.
