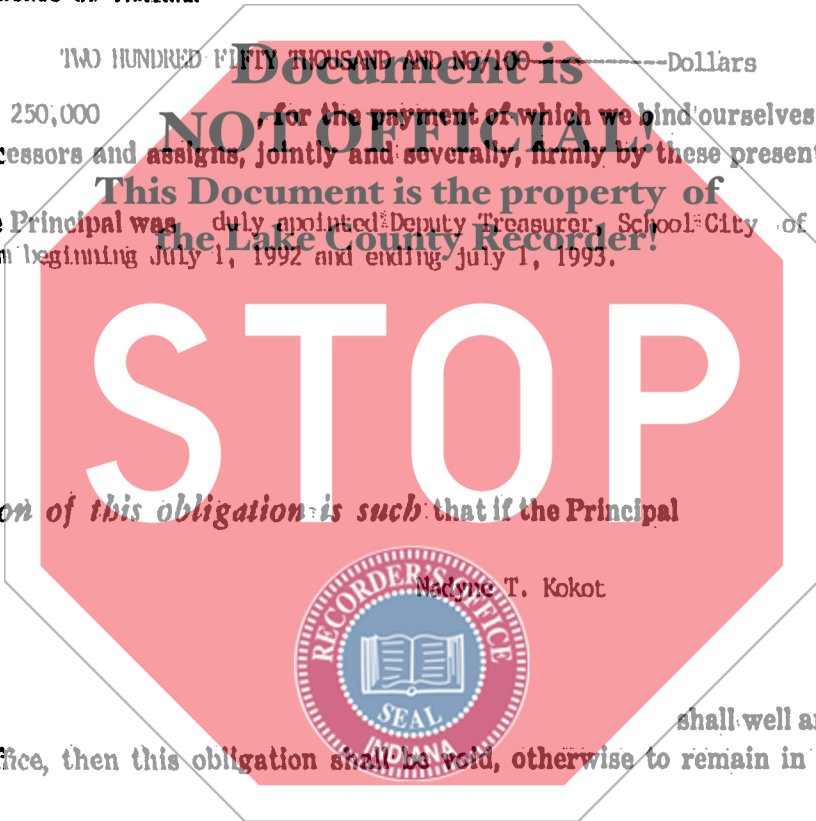

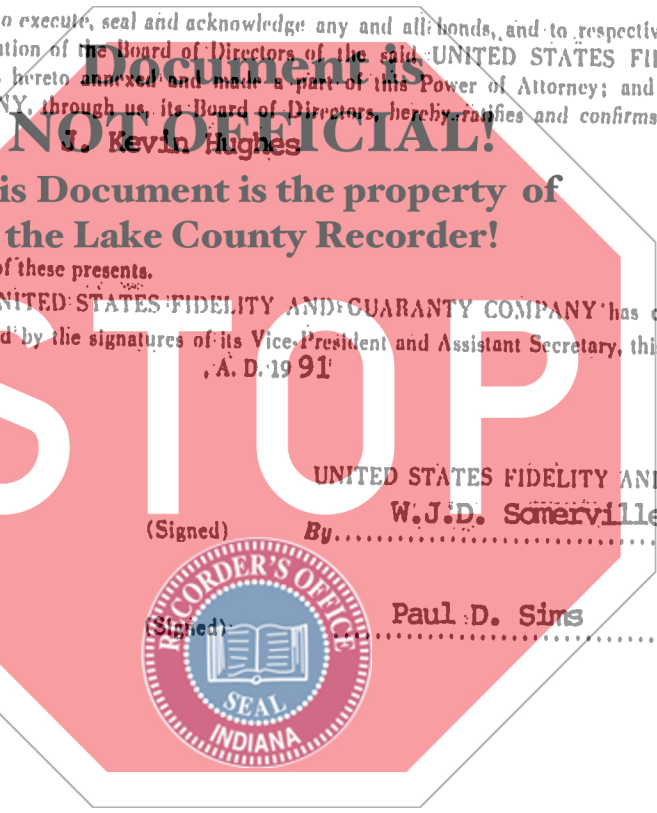

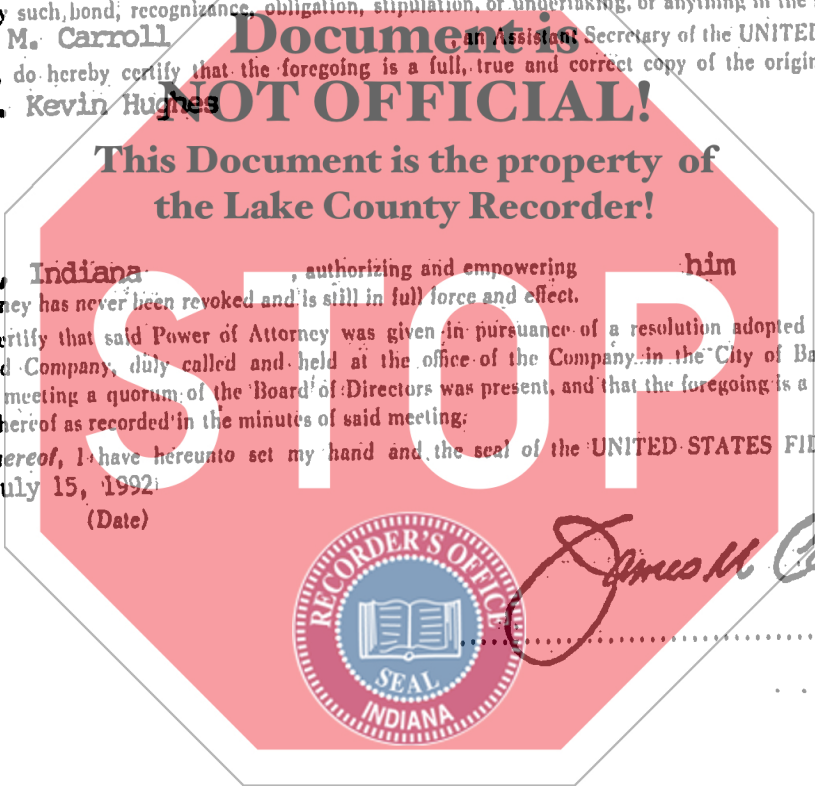
COPY OF RESOLUTION
