The interest rate as computed is changed once a month on the first day of each Billing Cycle, which is monthly, and will remain in effect until the first day of the next Billing Cycle: The FINANCE CHARGE is determined by applying the daily periodic rate to the Average Daily Balance for the Billing Cycle. The interest rate shall not be in excess of that permitted by law.

2. TAXES AND CHARGES. 3. INSURANCE. Each said policy shall not be cancellable by the insurance company without at least thirty (30) days prior written notice to the Mortgagee.
