- 19 Payments. I agree to make all payments on the secured debt when due: Unless we agree otherwise, any payments you receive from me or for my benefit will be applied first to any amounts I owe you on the secured debt exclusive of interest or principal, second, to interest and then to principal. If partial prepayment of the secured debt occurs for any reason, it will not reduce or excuse any subsequently scheduled payment until the secured debt is paid in full:
- 2. Claims against:Title-1 will pay all taxes, assessments, liens, encumbrances, lease payments, ground rents, and other charges-relating to the property when due. It also agree that you and any party to this mortgage may extend, modify or make any other changes in the terms of this mortgage or the secured debt without my consent. Such a change will not release me from the terms of this mortgage.

The duties and benefits of this mortgage shall bind and benefit the successors and assigns of either or both of us.

15.* Notice* Unless otherwise required by law, any notice to me should give by delivering it or by mailing it by first class mail addressed to me at the Property. Address or any other address that I tell your will give any notice to you by certified mail to your address on page 1 of this mortgage, or to any other address which you have designated.

Any notice shall be deemed to have been given to either of us when given in the manner stated above.
