SATISFACTION OF MORTGAGE

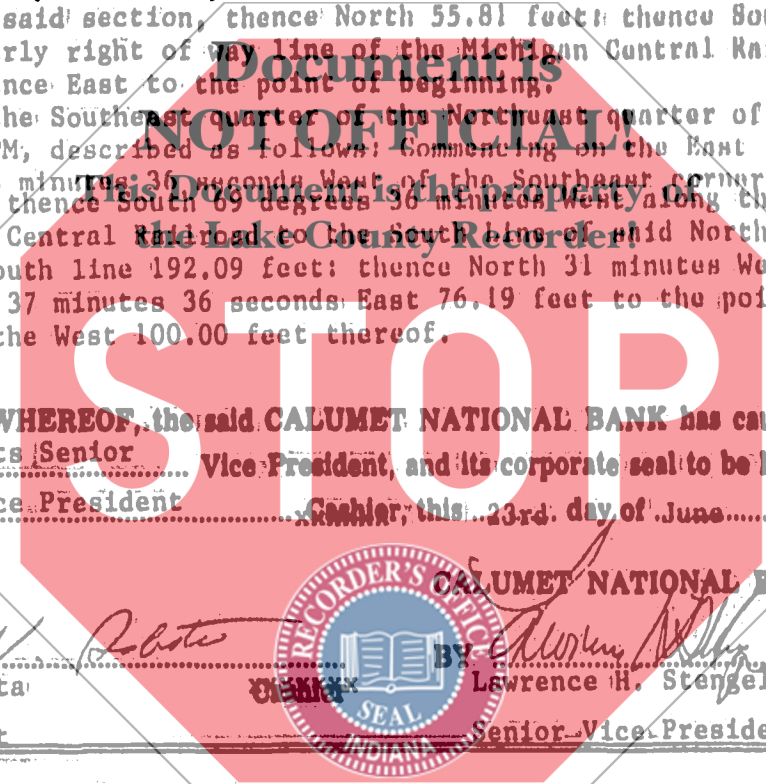
THIS CERTIFIES, that a certain Mortgage executed by Wallace D. Haney

West along the Northwesterly right of way line of the Michigan Central Railroad to the South line of
said quarter section; thence East to the point of beginning.

Parcel II: That part of the Southeast quarter of the Northeast quarter of Section 36, Township 36 Nth
Range 9 West of the 2nd PM, described as follows: Commencing on the East line of said Section 36 at a

County, Indiana, except the West 100.00 feet thereof.

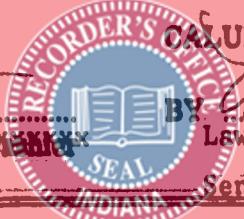
