1. That she is the surviving spouse of Frederick G. Richmond who died intestate a resident of Lake County on the 1st day of September, 1992.

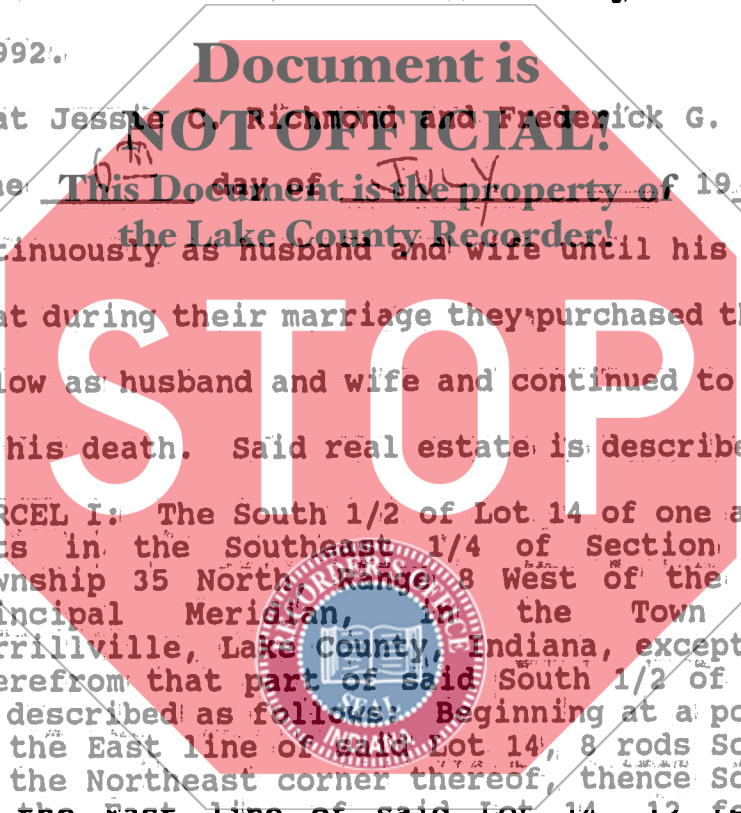
2. That Jessie C. Richmond and Frederick G. Richmond were married on the 1st day of JULY, 1954, and lived together continuously as husband and wife until his death.


