- 1. Mortgagor is the owner of said premises in fee simple or such other estate as is stated herein:
- 2. Mortgagor will pay the indebtedness as provided in said note and this mortgage. Privilege is reserved to prepay at any time; without premium or fee, the entire indebtedness or any part thereof not less than the amount of one installment, or one hundred dollars (\$100.00); whichever is less. Prepayment in full shall be credited on the date received. Partial prepayment; other than on an installment due date, need not be credited until the next following installment due date or thirty days after such prepayment, whichever is earlier.
- 3. Mortgagor will pay to the Mortgagee; as trustee, (under the terms of this trust as hereinafter stated) together with, and in addition to, the monthly payments under the terms of the note secured hereby, on the first day of each month until the said note is fully paid:

This Rider, attached to and made part of the Mortgage, Mortgage Deed; Deed of Trust, Security Deed or Vendor's Lien. (the "Security Instrument") between PETER T. SAIMS (the "Borrower") and FLEET MORTGAGE CORP. (the "Lender") dated JULY 6, 1993; revises the Security Instrument as follows:

- 1. <u>Due-On-Sale</u>: This loan may be declared immediately due and payable upon transfer of the property securing such loan to any transferce, unless the acceptability of the assumption of the loan is established pursuant to section 1814 of Chapter 37, title 38, United States Code.
- 2. Funding Fee: A fee equal to one-half of one percent of the balance of this loan as of the date of transfer of the property shall be payable at the time of transfer to the loan holder or its authorized agent, as trustee for the Secretary of Veterans Affairs. If the assumer fails to pay this fee at the time of transfer, the fee shall constitute an additional debt to that already secured by this instrument, shall bear interest at the rate herein provided, and, at the option of the payee of the indebtedness hereby secured or any transferee thereof, shall be immediately due and payable. This fee is automatically waived if the assumer is exempt under the provisions of 38 U.S.C. 1829 (b).
- 3: Processing: Charge: Upon application for approval to allow assumption of this loan, a processing feemay be charged by the loan holder or its authorized agent for determining the creditworthiness of the assumer and subsequently revising the holder's ownership records when an approved transfer is completed. The amount of this charge shall not exceed the maximum established by the Veteran's Administration for a loan to which section 1814 of chapter 37, title 38, United States Code applies.
- 4. <u>Indemnity</u> Liability: If this obligation is assumed, then the assumer thereby agrees to assume all of the obligations of the veteran under the terms of the instruments creating and securing the loan, including the obligation of the veteran to indemnify the Veterans Administration to the extent of any claim payment arising from the guaranty or insurance of the indebtedness created by this instrument.
- 5. The borrower further agrees that should this Security Instrument and the note secured hereby not be eligible for guarantee under the Servicemen's Reading ment act of 1944 as amended within 90 days from the date hereof (written statement of any officer of the Veterans Administration or authorized agent of the Secretary of Veterans Affairs dated subsequent to the 90 days time from the date of this security instrument, declining to guarantee said note and this mortgage, being deemed conclusive proof of such ineligibility); the Lender or the Holder of the note may at its option declare all sums secured hereby immediately due and payable.
