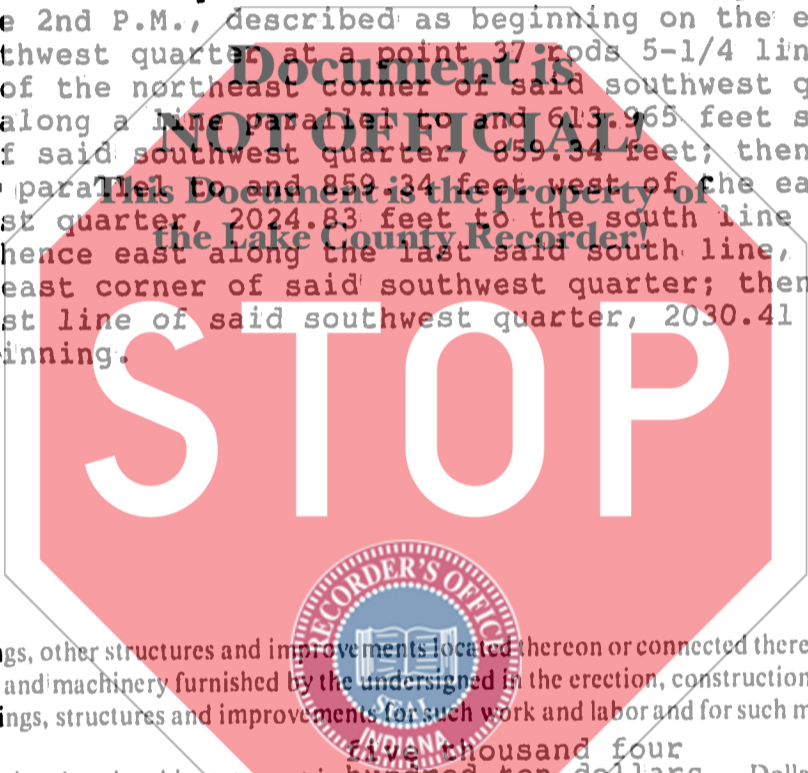
The undersigned, being first duly sworn, makes this sworn statement of intention to hold a lien upon the property described below and says that:
