- 6. REPRESENTATIONS, WARRANTIES AND COVENANTS. Grantos represents, warrants and covenants to Lender that:
 - (a). Grantor has fee simple title to the Property and has full power to Mortgage it. Grantor shall maintain the Property free of all liens, security interest, encumbrances and claims except for this Mortgage and those described in Schedule 8 which is attached to this Mortgage and incorporated herein by reference. Grantor will warrant and defend the title to the Property against all lawful claims and demands and will make any further assurances of title that Lender may require:

- 13. INSURANCE. The Property will be kept insured for its full value against all hazards including loss or damage caused by fire, collision, theft or other casualty. Grantor may obtain insurance on the Property from such companies as are acceptable to Lender in its sole discretion. The insurance policies shall require the insurance company to provide Lender with at least thirty. (30) days! written notice before such policies are altered or cancelled in any of Lender, to be paid the insurance proceeds pertaining to the loss or damage of the Property. - 18. TAXES AND ASSESSMENTS.  - (a) fails to pay any Obligation to Lender when due;
 - (b) falls to perform any Obligation or breaches any warranty or covenant to Lender contained in this Mortgage or any other present or future; written
 - (c) allows the Property to be damaged, destroyed, lost or stolen in any material respect;
 - (d): seeks to revoke, terminate or otherwise limit its liability under any guaranty to Lender;
 - (e) allows the Property to be used by anyone to transport or store goods the possession, transportation, or use of which, is illegal;
 - (f): causes Lender to deem itself insecure in good faith for any reason.
- 22. RIGHTS OF LENDER ON DEFAULT. If there is a default under this Mortgage, Lender shall be entitled to exercise one or more of the following remedies without notice or demand (except as required by law):
 - (a) to declare the Obligations immediately due and payable in full;
