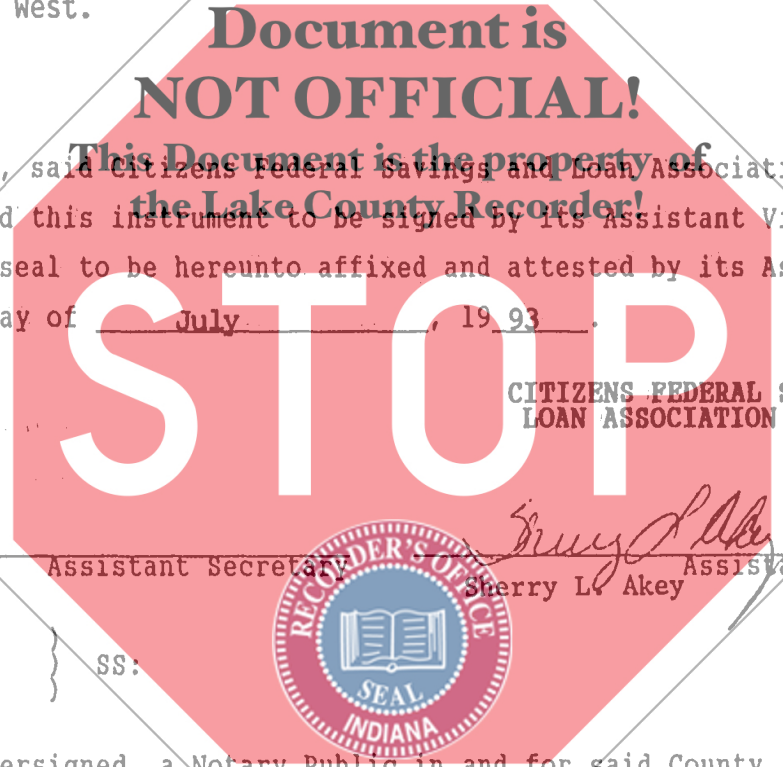
THIS CERTIFIES, that a certain Mortgage executed by Clifford C. Watts and Micki L. Watts, husband and wife
