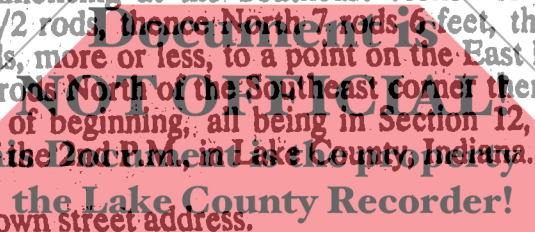
**CORPORATE QUIT CLAIM DEED**


