SUBORDINATION AGREEMENT OF MORTGAGE

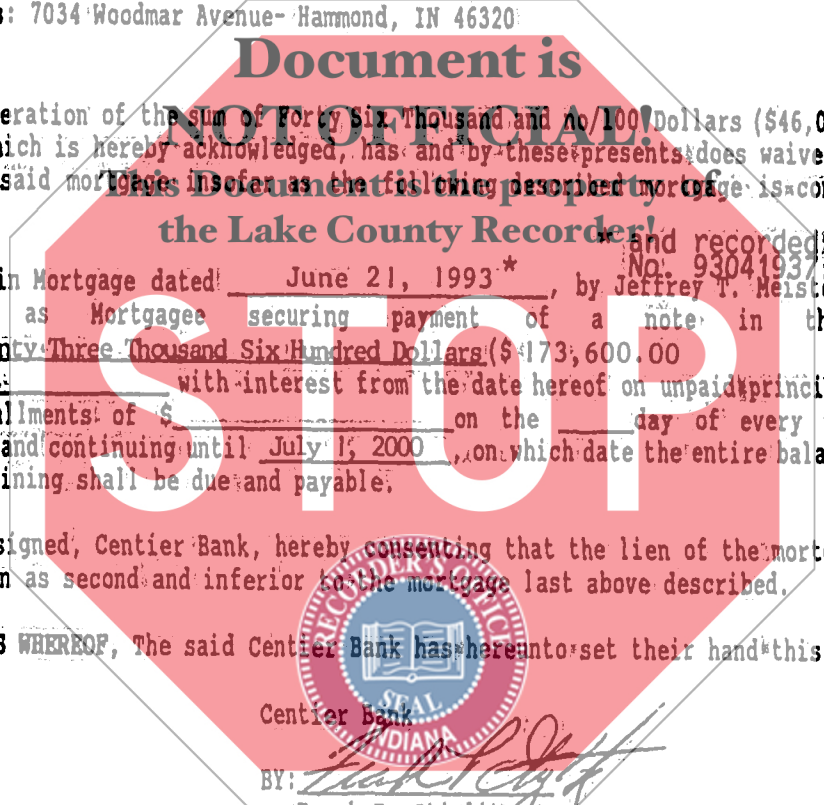
KNOW ALL MEN BY THESE PRESENTS THAT:

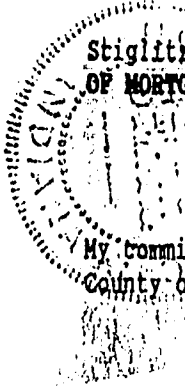
