SATISFACTION OF MORTGAGE

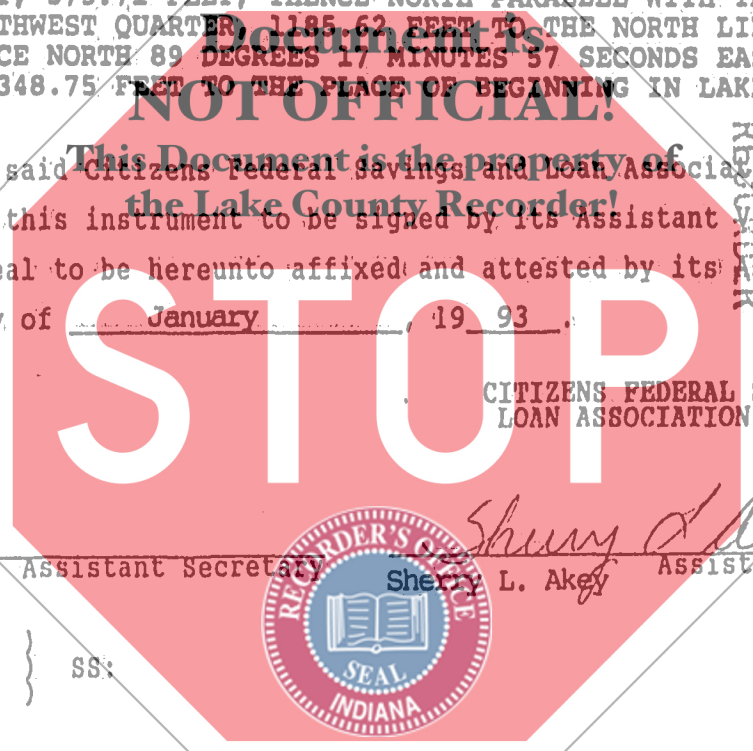

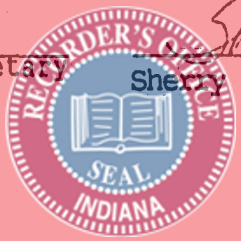
