EXHIBIT "A" RESTRICTIVE COVENANTS TO LOT 85, CANDLELIGHT TRAILS FIFTH ADDITION

It is Agreed between the grantors, their successors and assigns, and the grantee, its successors and assigns, that as a part of the consideration for a deed the following covenants and restrictions shall run with the land conveyed and legally described as follows:

Lot 85 in Candlelight Trails Fifth Addition to the Town of St. John as recorded in plat book 67 page foruin the Office of the Recorder, Lake County, Indiana, and as amended by dertificate of correction recorded December 13, 1989 as document number 074192.

 1. That the park and recreational facility located upon Lot 85 shall be known as and is hereby dedicated as Prairie West Park, a memorial to the immigrant farmers who first settled the Town of St. John, then known as Western Prairie or Frairie West.
- 2. Lot 85 is hereby dedicated as a neighborhood park, not a community facility, for the primary purpose of providing park and recreation facilities to the residents of Candlelight Trails Suddivision and tracts of land immediately adjacent to Candlelight Trails Subdivision, provided however, that this coverant shall not be deemed to prohibit the use of the facility by the public at large so long as such use is consistent with these coverants.
- 3. Lot 85 shall be used by the park and Recreation Board of the Town of St. John solely for park and recreation purposes and no commercial activity shall be allowed thereon.
- 4. The installation of a baseball diamond, basketball court, tennis courts, or other group recreational facilities is encouraged, but their use is restricted to unorganized groups and persons, and the use of the park and recreational facility for organized sports including, but not limited to little leagues, soccer leagues, and/or football leagues is prohibited.
- 5. That permanent or temporary exceptions and waivers may be issued to the above and foregoing restrictive covenants, numbered 1 through and including 4, by Harold 6. Muenich, his heirs, successors, and/or assigns.

That should the land hereinabove described be used for any purpose inconsistent with the restrictions hereinabove set forth, unless removed or waived as set forth in covenant number 5 above, or in the event any of said restrictions be violated, then all right, title, and interest conveyed herein of the lands described above shall revert to Harold G. Muenich, his heirs, successors, and assigns, as trustees for the use and benefit of the residents of Candlelight Trails Subdivision consistent with the restrictions set forth above.
