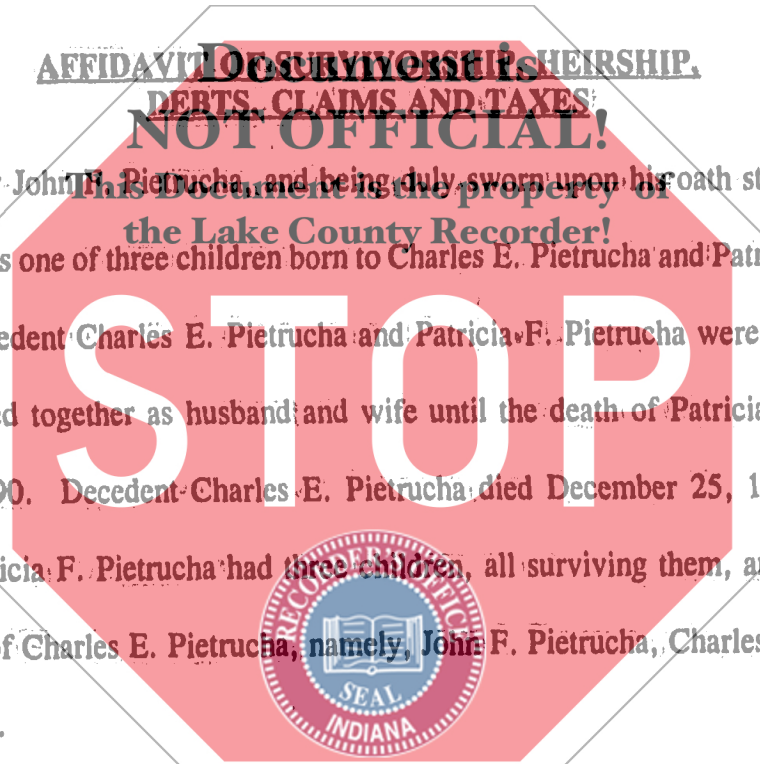
**AFFIDAVIT OF SURVIVORSHIP, HEIRSHIP,

Comes now John F. Pietrucha, and being duly sworn upon his oath states as follows:

1. He is one of three children born to Charles E. Pietrucha and Patricia F. Pietrucha.
2. Decedent Charles E. Pietrucha and Patricia F. Pietrucha were married October 17, 1953, and lived together as husband and wife until the death of Patricia F. Pietrucha on November 18, 1990. Decedent Charles E. Pietrucha died December 25, 1992. Charles E. Pietrucha and Patricia F. Pietrucha had three children, all surviving them, and all adult at the time of the death of Charles E.
