Comes now Freya Lynn Davis, being duly sworn upon her oath and states as follows:

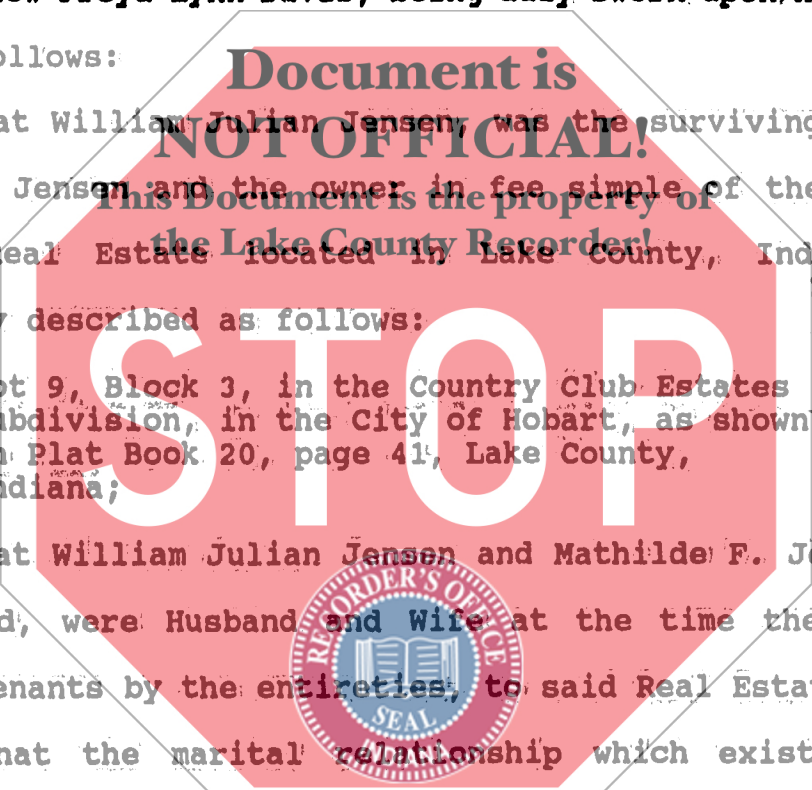

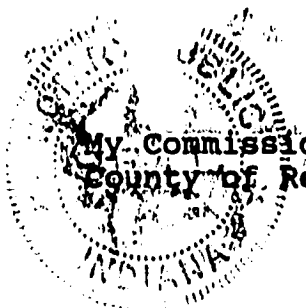
