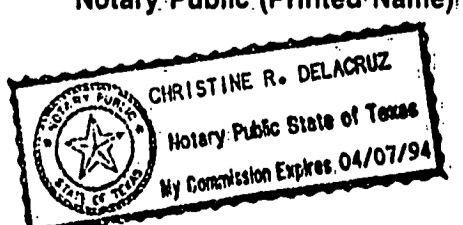

A part of the Northeast Quarter of Section 33, Township 32 North, Range 8 West, Lake County, Indiana, described as follows: Commencing at the Northwest corner of said quarter section; thence South 0 degrees 26 minutes 48 seconds East 1,180.00 feet along the west line of said quarter section to the center line of S.R. 55; thence North 89 degrees 58 minutes 45 seconds East 299.80 feet along said center line; thence South 24 degrees 13 minutes 15 seconds East 752.40 feet along said center line; thence South 4 degrees 36 minutes 15 seconds East 4.00 feet along said center line to the Northwest corner of the owners' land and the point of beginning of this description; thence North 82 degrees 13 minutes 45 seconds East 130.42 feet along the Northern line of the owners' land; thence South 8 degrees 57 minutes 57 seconds East 29.96 feet to the South line of the owners' land and the low water mark of the Kankakee River; thence South 82 degrees 13 minutes 45 seconds West 132.70 feet along said low water mark to the center line of said S.R. 55; thence North 4 degrees 36 minutes 15 seconds West 30.00 feet along the center line of said S.R. 55 to the point of beginning and containing 3,941 square feet, more or less.
